CHARGE

I, Rajeshwari N. Hegde, B.Com., LL.M, Principal District & Sessions Judge and Special Judge, Chikkamagaluru, do hereby charge you:

- CCL.1 Lukith R, S/O.Ram Babu, 17 years, 1st year Diploma student, Polytechnic college, R/a Shankarapur, Chikkamagalur.
- CCL.2 Pawan S., S/O.Srinivasa, 17 years, 1st year Diploma student, Polytechnic college, R/a Shankarapur, Chikkamagalur.

as follows:

That on 3.4.2022 accused No.4 near Gavanahalli Anjaneya temple made a demand with Druvaraj Urs to return the amount borrowed by him by next day evening and deterred him with dire consequences if he fails to return the amount and thereafter you CCL Nos.2 and 3 along with accused Nos.1 and 2, in furtherance of your common object, hatched conspiracy to do away the life of Druvaraj Urs, if he fails to return the amount and thereby you CCLs committed criminal conspiracy punishable under section 120-B R/w section 34 of Indian Penal Code and within the cognizance of this

Special Court.

That on the aforesaid date, time and place you CCL No.2 and 3 , alongwith accused No.4 criminally intimidated the deceased Druvaraj Urs threatening him to repay the loan within next day evening and thereby committed an offence punishable under Section 506 r/w. 34 of I.P.C., within the cognizance of this Court.

That on 4.4.2022 at about 7.30 p.m. near water tank, Kote, Chikkamagaluru Town, coming within the jurisdiction of Town Police Station, Chikkamagaluru, when deceased Dhruvaraja, and CW1-Rakesh came on the motorbike, in furtherance of your common intention, you CCL NO.2 and 3 alongwith accused No.1 was present there and when deceased Dhruvaraja went near accused No.1 to talk with him, at that time, accused No.1 with common intention abused the deceased in filthy language asking him to repay the loan of Rs.20,000/- borrowed through him from others and thereby insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under section 504 r/w Section 34 of I.P.C., within the cognizance of this Court.

That, on the aforesaid date, time and place, in furtherance of your common intention, you CCL NO.2 gave a signal to CCL.No.3 to bring the scooty to the spot, accordingly. CCL No.3 brought the Scooty bearing No.KA:18:EH:1953 which was nearby the place, immediately, accused No.1 took a knife which was kept in his back and stabbed Devaraj Urs on the left side of the stomach with a loud force, and caused bleeding injuries, then immediately, you CCL No.2 and 3 flee away from the said spot alongwith accused No.1 in the said scooty , that at about 9.00 p.m. on the same day at M. G. Hospital, Chikkamagaluru , the deceased Dhruvaraja succumbed to the

injuries and thereby you CCL NO.2 and 3 alongwith other accused did commit murder of the deceased and thereby you CCLs committed an offence punishable under section 302 R/w section 34 of Indian Penal Code and within the cognizance of this Special Court.

And I hereby direct that you be tried by this court on the above said charges.
