C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl., Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

Narayana V., S/o Venkatesha, Aged 56
years, Businessman, R/at Behind
Kavery saw mill, Kempanahalli,
Chikkamagaluru.

as follows:

That on 29.11.2023 at about 9.45 p.m. in front of Gowthami Hotel, R.G. Road, Chikkamagaluru within the jurisdiction of Basavanahalli Police Station, when CW.1- Lokesh was in his above said Hotel, you the accused came near said hotel and abused CW.1 in filthy language with regard to he lodging the complaint against you before the court in PCR No.100/2023 for non-payment of loan of Rs. 4,00,000/- borrowed by you from him and gave provocation, knowing fully well that such provocation would cause them to break the public peace and thereby committed an offence punishable under section 504 of Indian Penal Code and within my cognizance.

2. That on the aforesaid date, time and place, you the accused voluntarily caused simple hurt to CW.1 by assaulting him with hands on his person and thereby committed the offence punishable under Section 323 of Indian Penal Code and within my cognizance.

3. That on the aforesaid date, time and place, you the accused voluntarily caused simple hurt to CW.1 by assaulting him with a plywood sheet on his hand, right thumb finger and near left eye and thereby committed the offence punishable under Section 324 of Indian Penal Code and within my cognizance.

4. That on the aforesaid date, time and place, you the accused issued threat to the life of CW.1 and thereby committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code and within my cognizance.

5. That on the above said date, time and place, you the accused not being the member of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1, member of a Scheduled Caste by abusing him by touching the name of his caste with intent to humiliate him within public view and thereby committed the offence punishable under Section 3(1) (r) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

6. That on the above said date, time and place, you the accused not being the member of any Scheduled Caste or Scheduled Tribe, abused CW.1, member of a Scheduled Caste by touching the name of his caste within public view and thereby committed the offences punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act,

and within my cognizance.

7. That on the aforesaid date, time and place, you the accused not being the member of any Scheduled Caste or Scheduled Tribe, committed the offence under Sections 323, 324 and 506 of I.P.C. against CW.1 knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
