CHARGE

I K.L.Ashok, B.Com., L.L.B., 1st Addl. Sessions and Spl. Judge,
Chikkamagaluru, do hereby charge you:

1. Thammaana Gowda S/o Late Channappa Gowda, Aged about 46 years, Agriculturist, R/o Janige Village, Harmakki, Gonibeedu Hobli, Mudigere Taluk.
2. Ganapathi Gowda S/o Sannegowda, Aged about 55 years, Agriculturist, R/o Harmakki Janige, Gonibeedu Hobli, Mudigere Taluk.
3. Suresha S/o Late Krishne Gowda, Aged about 42 years, Agriculturist, R/o Janige Village, Harmakki Janige, Gonibeedu Hobli, Mudigere Taluk.
4. Jeevan S/o Late Jayarame Gowda, Aged about 25 years, R/o Janige Village, Harmakki Janige, Gonibeedu Hobli, Mudigere Taluk.
5. Chethan H.G. S/o Ganapathi Gowda, Aged about 21 years, Student, R/o Janige Village, Harmakki Janige, Gonibeedu Hobli, Mudigere Taluk.

as follows:

That on 12.12.2014 at about 10-30 a.m, near the water tank of Harmakki Village, Gonibeedu Hobli, Mudigere Taluk, you accused No. 1 to 5, being the members of unlawful assembly and in prosecution of the common object thereof, in connection with holding water from the water tank, you accused No. 1, 2, 4 and 5 abused C.W. 1 Prakasha in filthy language and thereby insulted him and provoked him to commit breach of peace and thereby committed an offence punishable under Section 504 R/w Sec.149 of I.P.C. and within the cognizance of this Court of Sessions.

2. Secondly, on the above said date, time and place, you accused No. 1 to 5, being the members of unlawful assembly and in prosecution of the common object thereof, you accused No.3 assaulted C.W. 1 Prakasha with a club on his shoulder and caused simple injuries to C.Ws.1, 4 and 5 and thereby committed an offence punishable under Section 324 R/w Sec. 149 of I.P.C. and within the cognizance of this Court of Sessions.

3. Thirdly, on the above said date, time and place, you accused No. 1 to 5, being the members of unlawful assembly and in prosecution of the common object thereof, you accused No.4 fisted C.W. 1 with hands on his face, you accused No.5 kicked C.W. 1 with legs on his stomach and as a result C.W. 1 sustained simple injuries and thereby committed an offence punishable under Section 323 R/w Sec. 149 of I.P.C. and within the cognizance of this Court of Sessions.

4. Fourthly, on the above said date, time and place, you accused No. 1 to 5, being the members of unlawful assembly and in prosecution of the common object thereof, criminally intimidated C.W. 1 by giving life threat and thereby committed an offence punishable under Section 506 R/w Sec. 149 of I.P.C. and within the cognizance of this Court of Sessions.

5. Fifthly, on the above said date, time and place, you accused No. 1 to 5 not being the members of Scheduled Castes or Scheduled Tribes, intentionally insulted C.W.1 members of Scheduled Caste, with intent to humiliate them within public view, by abusing them by touching the name of their caste and thereby committed an offence punishable under Section 3(1)(x) of SC & ST (Prevention of Atrocities) Act, 1989 and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said charges.
