Sessions Judge, Chikkamagaluru, do hereby charge you:

A1 Nithish S/o Mohan,
Aged about 28 years,
R/o Agasara Beedi,
Canara Bank Road, Chikkamagaluru.

A2 Akshay Kumar S/o Sathish.
Aged about 27 years,
R/o Nekara Road, Opposite Rama
Mandira, Chikkamagaluru.

A3 Manoj Kumar
Aged about 24 years,
R/o Nekara Beedi, Opposite Rama
Mandira, Chikkamagaluru.

A4 Harvin Acchayya S/o Ramesh K.K,
Aged about 33 years,
R/o K.M.Road, Anjaneya Industries,
Chikkamagaluru.

as follows:

That on 17.03.2023 at about 10.00 p.m, you accused
No.2 nurtured vengeance against CW.1-Shreyas with

regard to filling of petrol in the petrol bunk situated at Hanumanthappa Circle, Chikkamagaluru, on account of enmity in the said regard, that on 18.03.2023 at about 5.00 p.m, when CW.1 and CW.2-Nikhil Suraj @ Chintu went to the Tasty Point Tea stall situated at Tarikere-Chikkamagaluru main road for having coffee, thereafter CW.1 and CW.2 in order to return to home came opposite to Taste General Store road, situated at Tarikere-Chikkamagaluru main road within the jurisdiction of Basavanahalli police station, at about 5.30 p.m., you accused No.1 to 4 went to the spot on the Royal Enfield motor bike bearing registration No.KA-18/EH-6161 belonging to you accused No.1 and Activa Honda Scooty bearing registration No.KA-50/EC-1502 with common intention obstructed CW.1 from proceeding further in a direction in which he had every right to proceed and thereby you the accused committed an offence punishable under section 341 of Indian Penal Code r/w Section 34 of said Code and within my cognizance.

2. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 abused CW.1 in filthy language and gave provocation, knowing fully well that such provocation would cause him to break the public peace and thereby committed an offence punishable under section 504 of Indian Penal Code r/w Section 34 of said Code and within my

cognizance.

3. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 tried to stab with knife on CW.1's stomach, CW.1 tried to escape from the blow and turned to right, at that time, you accused No.1 stabbed him on his back two times with knife and thereby having voluntarily caused simple hurt to CW.1 with knife, you accused committed an offence punishable under section 324 of Indian Penal Code r/w section 34 of the said Code and within my cognizance.

4. That on the aforesaid date, time and place, in furtherance of your common intention, you accused Nos.1 to 4 pushed CW.1 with your hands and made him to fall down and kicked on his person and thereby caused simple hurt to CW.1 and thereby having voluntarily caused simple hurt to him, you accused committed an offence punishable under section 323 of Indian Penal Code R/w section 34 of the said Code and within my cognizance.

5. That on the aforesaid date, time and place, in furtherance of your common intention, you accused Nos.1 to 4 with an intention to commit the murder of CW.1 and with knowledge that by your act you would be causing his death and under such circumstances in which if by your act, CW.1 had died, you would have

been guilty of murder, you accused No.1 tried to stab CW.1's stomach with knife, CW.1 tried to escape from the blow and turned to right, at that time, you accused No.1 stabbed him on his back two times with knife and caused grievous injuries, thereafter, you accused Nos.1 to 4 pushed CW.1 with your hands and made him to fall and kicked on his person and caused simple hurt to CW.1 and when you accused No.1 again tried to pierce CW.1 with knife, CW.1 screamed, at that time, CW.2, CW.3- Nikhil and CW.4 Suhas pacified the quarrel and thereby you accused committed an offence punishable under section 307 of Indian Penal Code R/w section 34 of the said Code and within my cognizance.

6. That on the aforesaid date, time and place, in furtherance of your common intention, you accused Nos.1 to 4 threatened the life of CW.1 with dire consequences and thereby committed an offence of criminal intimidation punishable under section 506 R/w section 34 of the said Code and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
