CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

Manu K.M., S/O.Marulappa, Aged 34
years, Labourer, Kanchukal village,
S.Bidre post, Singatagere Hobli, Kadur
Taluk, Chikkamagalur District.

as follows:

That since 15 days prior to 20.11.2021 you accused
and deceased Sheshappa @ Shashi S/O.Shanthappa, were
residing in a single house in the coolie lane, belonging to
CW.14, in Sy.No.212/p of Hirekolale village and every day,
during night hours, you and Sheshappa were quarreling with
each other and on 17.11.2021 at about 5.00 PM and you
accused and Sheshappa @ Shashi were quarreling with
each other and CW.14 questioned as to why the quarrel is

going on and advised not to quarrel, inspite of it you did not stop the quarrel and in between 5.00 PM and 6.00 PM you accused abused Sheshappa in filthy language with regard to cooking matter and brought the sickle from kitchen, assaulted Sheshappa @ Shashi on the neck, face, chin, near the nose with a sickle and dragged Sheshappa to the room, pierced Sheshapp @ Shashi with a knife for several times on the stomach, said Sheshappa @ Shashi got injured and later succumbed to the injuries and thereby committed murder of Sheshappa @ Shashi punishable under section 302 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place, you accused, in order to screen the evidence of offence from legal punishment, after murdering Sheshappa @ Shashi , took the sickle and knife used for the commission of the offence and the blood stained clothes in a bag and went away from the spot and thereby you have committed the offence of causing disappearance of evidence punishable

under section 201 of IPC and within the cognizance of the court.

Lastly, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, committed an offence under Section 302, 201 of IPC punishable with life imprisonment , knowing that he is a member of Scheduled Caste and thereby committed an offence punishable under Sec. 3(2)(v) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this court.

And I hereby direct that you be tried by this Court on the said charges.
