CHARGE

I, K.L.Ashok, B.Com., LL.B, 1st Addl. Dist. & Sessions Judge,
Chikkamagaluru, do hereby charge you:

Madhu, S/o Manjappa, Aged about____
years, Coolie, R/o Bankanakatte, Shivani
Hobli, Ajjampura Taluk, Chikkamagaluru
District.

as follows:

That on 29.11.2018 at about 11.00 p.m. at Bankanakatte
Village, Ajjampura Taluk, coming within the jurisdiction of
Ajjampura Police Station, when CW1 Manjappa was standing in
front of the house of one Parameshwarappa and was talking over
phone, at that time, a stone thrown by somebody towards a dog
went near the house of grandmother of you accused and in that
regard, you accused abused CW1 in filthy language and thereby

insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under Section 504 of I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, place and time, you accused voluntarily caused hurt to CW1 Manjappa by assaulting him with hands on his person and thereby committed the offence punishable under section 323 of I.P.C., and within the cognizance of this Court.

Thirdly, on the above said date, time and place, you accused voluntarily caused grievous hurt to CW1 Manjappa by assaulting him with a club on his right hand, right neck and thereby committed an offence punishable under Section 326 of I.P.C., and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, you accused criminally intimidated CW1 Manjappa by giving life threat and thereby committed an offence punishable under Section 506 of I.P.C. and within the cognizance of this Court.

Fifthly, on the above said date, time and place, you accused not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1 Manjappa, member of Scheduled Caste, with intent to humiliate him within public view, by abusing him by touching the name of his caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Sixthly, on the aforesaid date, time and place, you accused not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323 and 506 of I.P.C. against CW1 Manjappa knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, committed an offence under Section 326 of IPC punishable with

imprisonment for a term of 10 years or more against CW1 Manjappa knowing that he is a member of Scheduled Caste and thereby committed an offence punishable under Sec. 3(2)(v) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
