CHARGE

I, Manjunath Sangreshi., B.A., LL.B.,(HONS), II Addl., District and
Sessions Judge, Chikkamagaluru, do hereby charge you,

1. Smt.Asharani W/o Swamy,
Aged about 25 years, Housewife,
R/o Sunnigere, Channagiri Taluk,
Present at: C/o D.Chandrashekar Naidu,
276/1/2/1, Chikkabettahalli village,
Vidyaranyaपुरa, Bengaluru.

2. Vijayakumara S/o Late Sidramappa,
Aged about 51 years, Agriculturist,
R/o Benikere village, Channagiri Taluk,
Davanagere District.

3. Bharath S/o Vijayakumara,
Aged about 22 years, Student,
R/o Benkikere, Channagiri Taluk,
Davanagere District.

4. Smt.Pushpavathi W/o Vijayakumar,
Aged 48 years, (**Spit up**)

as follows:

That the deceased Rudraswamy had close intimacy with you accused No.1, when you accused No.1 was taking bath the deceased videographed the same in his mobile and thereafter the deceased started blackmailing you accused No.1 stating that he had some nude photographs of you accused No.1 and he would expose the same to her husband. Further accused No.1 intimated this fact to you accused No.2 to 4 and with common intention did criminal conspiracy, on 06.11.2008 at Benkikere village, all of them hatched a plan to finish said Rudraswamy and thereby committed the offence punishable under section 120-B R/w section 34 of IPC and within the cognizance of this Court.

That on 07.11.2018 at about 5.30 p.m., in the land of you accused No.2 bearing Sy.No.58/2 of Benkikere village, within the limits of Ajjampura Police Station, in furtherance of common intention to commit murder of Rudraswamy, when you accused No.3 was picking a coconut in the land, you accused No.1 assaulted said Rudraswamy with chopper on his right neck, split up accused shouted saying chopped the deceased, you accused No.2 assaulted Rudraswamy with sickle on his neck 3 to 4 times and you accused No.2 separated the head of the deceased from his body and committed the murder of Rudraswamy and thereby committed the offence punishable under section 302 R/w section 34 of IPC and within the cognizance of this Court.

That on the above said date, time and place, you accused and split up accused in furtherance of common intention, in order to screen the evidence of offence from legal punishment, after murdering

Rudraswamy, took the dead body of the deceased in a Maruthi Wagnar bearing Regd No.KA-04/MJ-3847 towards Bukkambudi, parked the car near the pond, kept the headless body in a gunny bag, tied stone to the said bag, threw it in a Bukkarayanaka kere, near Bukkambudi and threw the head in an another pond. Further you threw mobile sets of the deceased after smashing them along with car key of the deceased. Further you accused No.2 washed the blood stained chopper and sickle which were used to assault and threw them in the bush near the Neelagiri plantation and burnt the cloths of the deceased and threw the burnt ash of the cloth to the bush and thereby you have committed the offence of causing disappearance of evidence punishable under section 201 R/w section 34 of IPC and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
