C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl., Sessions and
Special Judge, Chikkamagaluru, do hereby charge you:

1. Akram S/o Hasen, aged 28 years,
Real estate dealer, R/at near
Puribatti, Shanthinagara, Market
Road, Chikkamagaluru.
2. Naseer S/o Hasen, aged 32 years,
Business, R/at Market Road, Behind
Muthu Mariyamma Temple,
Shanthinagara, Chikkamagaluru.
3. Abrahar S/o Hasen, aged 26 years,
Labourer, R/at near Puribatti,
Shanthinagara, Market Road,
Chikkamagaluru.

as follows:

That on 06.8.2024 at about 11.30 p.m. in front of the
house of CW.1-Ashwini and CW.6-Vijay @ Viji situated at
Market road, Chikkamagaluru Town, within the jurisdiction
of Women Police Station, you accused No.1 to 3 were
quarreling with CW.7-Manukumara, at that time when

CW.6-Vijay @ Viji went to pacify the quarrel, you accused Nos.1 to 3 with common intention, abused CW.6 in filthy language by questioning his right to intervene and further you accused Nos.1 and 2 abused CW.1-Ashwini in filthy language knowing fully well that such provocation would cause them to break the public peace and thereby you accused committed an offence punishable under section 352 of Bharatiya Nyaya Sanhita r/w Section 3[5] of the said Code and within my cognizance.

2. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and 2 assaulted CW.6-Vijay @ Viji with hands and caused simple hurt to him and thereby you having voluntarily caused simple hurt to CW.6, you committed an offence punishable under section 115[2] of Bharatiya Nyaya Sanhita r/w Section 3[5] of the said Code and within my cognizance.

3. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.2 assaulted CW.6 with wooden pole on his right hand and caused grievous hurt and thereby you having voluntarily caused grievous hurt to CW.6, you committed an offence punishable under section 118[2] of Bharatiya Nyaya Sanhita r/w Section 3[5] of the said Code and within my cognizance.

4. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and 2 used criminal force on CW.1-Ashwini, dragged her nighty and made her to fall down on the ground with an intent to outrage her modesty and thereby you accused committed an offence punishable under section 74 of Bharatiya Nyaya Sanhita r/w Section 3[5] of the said Code and within my cognizance.

5. That on the aforesaid date, time and place, in

furtherance of your common intention, you accused Nos.1 to 3 threatened the life of CW.1 and CW.6 with dire consequences and thereby you the accused committed an offence of criminal intimidation punishable under section 351[2] of Bharatiya Nyaya Sanhita r/w Section 34 of the said Code and within my cognizance.

6. That on the aforesaid date, time and place, you accused No.1 to 3 not being the members of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1 and CW.6, the members of Scheduled Caste with intent to humiliate them within public view and thereby you accused committed the offence punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

7. That on the aforesaid date, time and place, you accused No.1 to 3 not being the members of any Scheduled Caste or Scheduled Tribe, abused CW.1 and CW.6, the members of a Scheduled caste by touching the name of their caste within public view and thereby you accused committed the offence punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

8. That on the aforesaid date, time and place, you accused No.1 and 2 not being the members of Scheduled Caste or Scheduled Tribe, intentionally touched CW.1, a woman knowing that she belongs to a Scheduled Caste and thereby you accused committed an offence punishable under Section 3(1)(w)(i) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

9. That on the aforesaid date, time and place, you accused Nos.1 to 3 not being the members of Scheduled Caste or Scheduled Tribe, committed the offence under Sections 115[2], 351[2], 118[2], 74 of BNS against CW.1 and

CW.6 knowing that they are the members of a Scheduled Caste and thereby you accused committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
