District and Sessions Judge, Chikkamagaluru, do hereby charge
you,

1. Chandrashekar @ Boti,
Chandru S/o Veeranna,
Aged about 52 years,
R/o Bovi Colony, 4th Cross,
Kodicamp, Tarikere.

2. Manju S/o Ramegowda,
Aged about 39 years,
Haleganguru, Lingadahalli Hobli,
Tarikere Taluk.

3. Murugesha S/o Kuppa,
Aged about 20 years,
R/o Haleganguru village,
Lingadahalli Hobli, Tarikere Taluk.

4. Smt. Devi W/o Chandrashekar,
Aged about 42 years,
R/o Bovi Colony, 4th Cross,
Kodicamp, Tarikere.

as follows:

That on 14.12.2016 at about 1.00 p.m., you accused No.2 and 3 have illegally tress-passed into Ganguru Reserved Forest and have cut and removed the sandal wood trees belonging to the Government and thereby committed an offence puhishable under sections 24(e) of the Karnataka Forest Act and within my cognizance.

Secondly, that on the above said date, time and place, both of you accused No.2 and 3 have illegally tress-passed into reserved forest area, have cut and removed the sandal wood trees belonging to the Government and were carrying sandal wood and sold the same to you accused No.1 and 4. You accused No.1 and 4 were found in possession of sandal wood weighing about 66 kg and chips of wild bore, in your house at Bhovi Colony, Kodicamp, Tarikere Town without any licence or permit and thereby committed an offence puhishable under sections 84 and 86 of Karnataka Forest Act, and within my cognizance.

Thirdly, that on the above said date, time and place, both of you accused No.2 and 3 have illegally transported the above said sandal wood from the forest area, without having any permit or licence with an intention to sell the same in contravention of section 144 of Karnataka Forest Rules and thereby committed the offence punishable under section 165 of the Karnataka Forest Rules and within my cognizance.

Lastly, that on the above said date, time and place, both of you accused No.1 and 4 have illegally hunted the pangolin in the forest area and stored 5.600 Kgs of chips and shells of wild boar/pangolin without any pass or permit with an intention to sell the same and thereby committed the offence punishable under section 51 of the Wild Life (Protection) Act and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
