CHARGE

I, Prakash V., B.A(L)., LL.B., C/c II Addl., District and
Sessions Judge, Chikkamagaluru, do hereby charge you:-

Nandisha S/o Late Kannappa,
Aged about 25 years,
R/o M.M. Camp,
Mudugodu,
Rangenahalli Village,
Lakkavalli Hobli,
Tarikere Town,
Chikkamagaluru District.

as follows:

That on 02.09.2023 at about 10.00 a.m, when the mother of the complainant CW.8-Saraswati was alone in her house situated at Rangenahalli village, you the accused having developed enmity with CW.8, as she along with CW.1-Saravana had advised you the accused not to abuse the female children in your Village without any reason, by standing on the road, went there, called her out from her house and abused her in filthy language and further on the same day at about 07.15 PM, when CW.1-Saravana was sitting on his bike by parking on the road leading to

Preetham Bar near the house of CW.13-Sujatha situated at Rangenahalli village, Tarikere Taluk within the jurisdiction of Lakkavalli Police Station, you accused went there in the bike bearing registration No.KA-14-EJ/7069, questioned him about lodging of complaint against you to the police and abused CW.1 in filthy language and gave provocation, knowing fully well that such provocation would cause him to break the public peace and thereby committed an offence punishable under Section 504 of Indian Penal Code and within my cognizance.

2. On the above said date, time and place, you the accused with an intention to commit the murder of CW.1-Saravana and with knowledge that by your act you would be causing death of CW.1 and under circumstances in which by your act CW.1 had died, you would have been guilty of murder, you accused assaulted CW.1 with a machete on his head and caused injuries to him and thereby committed an offence punishable under Section 307 of Indian Penal Code and within my cognizance.

3. On the aforesaid date, time and place, you the accused voluntarily assaulted on the head of CW1-Saravana with a machete and caused bleeding injuries to him with dangerous weapon and thereby committed an offence punishable under Section 324 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
