CHARGE

I, B.Pushpanjali, B.A.,LL.B., LL.M., 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

1. Sharath Y.R., S/O.Ravindra, Aged 26 years,
Agriculturist, R/a Yadathal, Nilubagilu
village, Hariharapura, Koppa Taluk,
Chikkamagalur.
2. Channakeshava M.P., S/O.Prakash, Aged 28
years, Agriculturist, Melbikkali, Nilubagilu
village, Hariharapura, Koppa Taluk,
Chikkamagalur.
3. Shivananda B.R., S/O.Ramapoojari, Aged 39
years, Agriculturist, R/a Bikkali, Nilubagilu
village, Hariharapura, Koppa Taluk,
Chikkamagalur.
4. Sandesha B.N.S/O.Narayana Poojari, Aged
35 years, Agriculturist, R/a Bikkali,
Nilubagilu village, Hariharapura, Koppa
Taluk, Chikkamagalur.

as follows:

That on 12.11.2020 at about 8.30 PM when CW.1 was standing in front of the shop of Suryakantha Shetty of Niluvagilu village, within the jurisdiction of Hariharapura police station, you accused with regard to CW.1 taking direct water connection to his house from the main water pipe, in furtherance of your common intention, picked up quarrel with him, abused him in filthy language and thereby insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under section 504 r/w. 34 of I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, time and place, you accused No.1 to 4 in furtherance of your common intention, you accused No.1 pushed him, you accused No.2 assaulted near the right ear with hands and you accused No.1, 3 and 4 assaulted on the person of CW.1 with hands and voluntarily caused hurt to CW.1 and that you thereby have committed an offence punishable under section 323 r/w. Section 34 of IPC and within the cognizance of this court.

Thirdly, on the above said date, time and place, you accused No.1 to 4 in furtherance of your common intention, threatened the

life of CW.1 with dire consequences and committed criminal intimidation and that you thereby have committed an offence punishable under section 506 r/w. 34 of IPC and within the cognizance of this court.

Fourthly, on the above said date, time and place, in furtherance of common intention, you accused No.1 to 4, not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1, member of Scheduled Caste/Tribe, with intent to humiliate him within public view, by abusing him by touching the name of his caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the above said date, time and place, you accused persons No.1 to 4 not being the members of Scheduled Caste or Scheduled Tribe, committed the offences punishable under Sections 323 and 506 of I.P.C. against CW1 knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable

under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
