CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. District and Sessions Judge, Chikkamagaluru, do hereby charge you:

1. Rangaswamy @ Thammaiah, S/O.Lakka Shetty, Aged 46 years, Businessman, R/a S.Bidre village, Kadur Taluk.
2. Smt.Leelavathi, W/o Laxmana Shetty, Aged about 26 years, R/a S.Bidre village, Kadur Taluk.

as follows:

That accused No.1 had illicit relationship with you accused No.2, who is the wife of CW.1 and on 2.03.2021 the deceased Poornima, who is the daughter of CW.1 came to know about the illicit relationship between you accused No.1 and 2 and in this regard at S.Bidre village, within the limits of Sakkarayapatna police, you accused No.1 and 2 in furtherance

of your common intention, posed threat on the life of deceased Poornima, if she discloses the illicit relationship of you accused to anybody and used to give torture to her and caused mental agony to said Poornima and thereby you have committed the offence punishable under section 506 r/w Section 34 of I.P.C., within the cognizance of this Court.

Secondly, on the aforesaid date, time and place since deceased Poornima inspite of threat on her by you accused, disclosed the fact of illicit relationship of you accused No.1 and 2 to CW.1, enraged by the same, in furtherance of your common intention, you accused No.2 abused deceased Poornima and assaulted deceased Poornima and instigated deceased Poornima to end her life and you accused No.1 posed threat on deceased Poornima stating that you will see how deceased poornima will go to school from tomorrow onwards, for all these reasons, on 7.3.2021 between 9.30 AM to 10.30 AM the deceased Poornima being disgusted in life, committed suicide by hanging herself with her veil to the wooden rafter of the house and you accused persons abetted the deceased to commit

suicide by your above said acts and thereby you have committed an offence punishable under Section 306 r/w Section 34 of I.P.C., within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said charges.
