CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

Arun Kumara S/o Shekarappa, Aged about
25 years, R/o Nandi Village, Lingadahalli
Hobli, Tarikere Taluk, Chikkamagaluru.

as follows:

That on 08.01.2023, in the morning when C.W.1-Hareesha
was having cattle grazing turn, on behalf of C.W.1, C.W.4-
Chandrappa, being the father of C.W.1 had been to the work of
cattle grazing, at about 12.00 noon when C.W.4 had been to the
land of one Hanumanthappa, situated at Nandi Village,
Lingadahalli Hobli, Tharikere Taluk, Chikkamagaluru District, you
accused No.1 abused C.W.4 in filthy language and thereby insulted
him and provoked him to commit breach of peace and thereby

committed the offence punishable under Section 504 of I.P.C., and within the cognizance of this Court.

2. That, on the aforesaid date, time and place, you accused No.1, in the course of the same transaction, assaulted CW-4 with a wooden club on his left leg, left hand and right portion of waist and caused grievous injuries to CW.4 and thereby committed the offence punishable under section 326 of I.P.C., within the cognizance of this Court.

3. That, on the aforesaid date, time and place, you accused in the course of the same transaction, criminally intimidated CW.4 by giving life threat to him and thereby committed an offence punishable under Section 506 of I.P.C. and within the cognizance of this court.

5. That, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW4 Chandrappa, member of Scheduled Caste, with intent to humiliate him within public view, by abusing him by touching the name of his caste, and thereby committed the

offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

6. That, on the aforesaid date, time and place, you accused not being the member of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 504, 326, 506 of I.P.C. against CW4 knowing that he is the member of a Scheduled Caste or a Scheduled Tribe and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
