Basappa K.M. @ Basavaraja,
S/o Late Marulasiddappa,
Aged about 63 years, agriculturist & Retired Teacher,
R/o Kanchugaranahalli village,
Sakharayapattana Hobli, Kadur Taluk.

as follows:

That you accused on 24.12.2018 at about 3.00 p.m., in
Kanchugaranahalli village, Kadur Taluk, within the jurisdiction of
Sakharayapattana Police Station, entered into the house of your wife
Smt.Jayamma who was living separately since 28 years, in order to
commit offence punishable with imprisonment for life by suspecting
her fidelity and thereby committed the offence punishable under section
450 of IPC and within the cognizance of this Court.

That on the above said date, time and place, you accused with an intention to kill your wife Smt.Jayamma, by suspecting her fidelity assaulted on her with motorbike chain and shot into her mouth with Pistol and caused death of your wife Smt. Jayamma and thereby committed an offence punishable under section 302 of IPC and within the cognizance of this Court.

That on the above said date, time and place you accused possessed fire-arm/Pistol without licence or permit, in contravention of section 3 of the Indian Arms Act with intent to use for unlawful purpose and caused death of your wife Smt.Jayamma with that fire arm and thereby you have committed the offence punishable under section 25 of Indian Arms Act and within cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
