C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. Sessions and
Special Judge, Chikkamagaluru, do hereby charge you:

Hoysala Raj @ Hoysala Raj Urs, S/o
Veeraraju, Aged 36 years, Agriculturist,
R/at Hosakote village, Ambale Hobli,
Chikkamagaluru Taluk.

as follows:

That on 26.12.2022 in between 8.00 p.m. and 8.30 p.m.
at Hosakote village, Chikkamagaluru Taluk within the
jurisdiction of Chikkamagaluru Rural Station, when CW.1-
Sunil after parking his tractor in front of the house of one
Chethan was proceeding by walk on the cement road in front
of the house of one Somegowda, you accused obstructed
CW.1 from proceeding further in a direction in which he
had every right to proceed and thereby you the accused
committed an offence punishable under section 341 of
Indian Penal Code and within my cognizance.

2. That on the aforesaid date, time and place, you the
accused abused CW.1 in filthy language by questioning him

as to why he was spreading rumour that you were due to pay amount to him and how much amount to be paid by you and gave provocation, knowing fully well that such provocation would cause him to break the public peace and that thereby committed an offence punishable under section 504 of Indian Penal Code and within my cognizance.

3. That on the aforesaid date, time and place, you the accused voluntarily caused simple hurt to CW.1 by dragging him holding his shirt and thereby you the accused committed an offence punishable under section 323 of Indian Penal Code and within my cognizance.

4. That on the aforesaid date, time and place, you the accused voluntarily caused simple hurt to CW.1 by assaulting him with a club on his person, stomach, leg and right hand and thereby you the accused committed an offence punishable under section 324 of Indian Penal Code and within my cognizance.

5. That on the above said date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1, a member of a Scheduled Caste by abusing him with intent to humiliate him within public view and thereby committed the offence punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

6. That on the above said date, time and place, you the accused not being the member of any Scheduled Caste or Scheduled Tribe, abused CW.1, a member of a Scheduled Caste by touching the name of his caste within public view and thereby committed the offence punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

7. That on the aforesaid date, time and place, you the accused not being the member of any Scheduled Caste or Scheduled Tribe, committed the offence under Sections 341, 323 and 324 of IPC against CW.1 knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
