Statement of the accused under Section 313 of Cr.P.C.

Q. No.1 : Have you heard the depositions of the witnesses?

Ans : ಹೌದು

Q.No.2 : PW.1-Sunil Kumar @ Suni has deposed that he was working under you accused and you had not paid his dues and on several occasions, he had requested you, despite which you did not pay and hence, he left the job with you and joined with Chethan and on 26.11.2023 when he was going to his house in front of house of Somegowda, at about 7.00-7.30 p.m, you obstructed him and told him which amount to be paid and abused him by saying 'ಹೊಲೆಯ ಸೂಳಿಮಗನೇ, ಮಾದಿಗ ಸೂಳಿಮಗನೇ' and then assaulted him with hands on his face and body and assaulted with club on his right hand. What have you to say?

Q.No.3 : PW.1 has further deposed that you further told him that if he informed with any person about the amount, he would be killed. What have you to say?

Q.No.4 : PW.1 has further deposed that after four days of lodging the complaint, police drew the mahazar at the spot shown by him in the presence of CW.2 and CW.3 and seized the club as per MO.1 which was used by you accused to assault him and took the photograph as per Ex.P3. What have you to say?

Q.No.5 : PW.2-Dhananjaya has deposed that the police conducted mahazar at the spot shown by CW.1 and seized club in his presence. What have you to say?

Q.No.6 : PW.3-Gopal has deposed that about 04 years ago, in between 8.30 p.m and 9.00 p.m, when he had been to the shop of Murthiraj, there was quarrel in front of house of Somegowda and when he went there, there was quarrel between you and CW.1 and you were assaulting CW.1 with stick and was abusing by saying 'ಹೊಲೆಯ ಮದಿಗೆ' and you also assaulted on his stomach and you left the stick there itself and ran away. What have you to say?

Q.No.7 : PW.4-Dr.Somashekhar has deposed that on 26.12.2022 at 9.45 p.m, he medically examined one Sunil Kumar with a history of assault and he issued wound certificate as per Ex.P5. What have you to say?

Q.No.8 : PW.5-Revanna P.D has deposed that on 27.12.2022 at 7.00 p.m, he went to Chikkamagaluru District Hospital and recorded the statement of CW.1. What have you to say?

Q.No.9 : PW.6-Muddappa has deposed that on 27.12.2022, he received the statement of CW.1 produced by CW.14 and registered the crime and sent the FIR. What have you to say?

Q.No.10 : PW.7-Purushotham N has deposed that in furtherance of orders of Superintendent of Police, Chikkamagaluru, he received the further investigation and went to the spot and conducted the mahazar and seized club and got the report from PDO, MESCOM, sketch from PWD, caste certificate from Tahsildar, wound certificate from doctor and received the certificate under section 65-B of Indian Evidence Act and recorded the statements of CW.4 and CW.5 and further statement of CW.1 and arrested you and released on bail and on completion of the investigation filed the charge sheet. What have you to say?
