CHARGE

I, B.Pushpanjali, B.A.,LL.B., LL.M., 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

Chandrappa C @ Chandra @ Chandrappa C.,
S/O.Chowdaiah, Aged 32 years, Labourer, /a
Kanchanaganga Estate Labour line, Kalledevarapura
village, Chikkamagalur.

as follows:

That on 31.3.2021 at about 9.30 PM at Kanchanaganga coffee
estate, Allampura, Kalledevarapura village, situated within the
limits of Chikkamagalur Rural police station, when CW.1, CW.10
and you accused were talking with each other by sitting in front of
the coolie lane of Kanchanaganga coffee estate, all of a sudden you
accused picked up quarrel with CW.1 and abused him in filthy
language and gave provocation to him knowing fully well that such
provocation would cause him to break the public peace and that and

thereby you have committed an offence punishable under section 504 of IPC and within the cognizance of this court.

Secondly , on the above said date, time and place you accused voluntarily caused simple hurt to CW.1 by assaulting him with hands on his person and that you thereby committed an offence punishable under section 323 of IPC and within the cognizance of this court.

Thirdly, on the aforesaid date, time and place, you accused voluntarily caused simple injuries to CW.1 by assaulting him with a sickle on his left shoulder and that you thereby committed an offence punishable under section 324 of IPC and within the cognizance of this court.

Fourthly, on the aforesaid date, time and place, you accused threatened the life of CW.1 with dire consequences and committed criminal intimidation punishable under section 506 of IPC and within the cognizance of this Court.

Fifthly, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1- Devaraj Naik member of Scheduled Caste/Tribe, by abusing him in filthy language by taking the name of

their caste, with intent to humiliate him within public view, and thereby committed the offences punishable under Section 3(1)(r)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the above said date, time and place, you accused not being the member of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 324, 506 of I.P.C. against CW1 knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2) (va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

And, I direct that you be tried by this court for the aforesaid offences.
