Complainant: State by Lakkavalli Police Station

CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. Dist. & Sessions &
Special Judge, Chikkamagaluru, do hereby charge you:

Lokesha, S/O.Purushothama Raju, Aged
36 years, Agriculturist, R/a Soppinamatti,
Karakutchi, Lakkavalli Hobli, Tarikere
Taluk.

as follows:

That on 30.5.2021 at about 4.15 PM on Karakutchi –
Soppinamatti village public road, in front of the house of CW.1,
within the jurisdiction of Lakkavalli police station, while jelli metling
road forming work was going on, CW.1 asked with one Vishwanath
to make cement concrete road by asking with the MLA as the tar
road will be damaged during rainy season, you accused abused
CW.1, CW.4 and CW.5 in filthy language, by taking the name of
thier caste and thereby insulted them and provoked them to commit

breach of peace and thereby committed the offence punishable under section 504 of I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, time and place, you accused assaulted CW.1 with hands on his person and when CW.4 and CW.5 intervened to separate the scuffle, you accused also assaulted them with hands on the back and neck of CW.4 and on the head of CW.5, dragged CW.4 by holding his shirt collar and voluntarily caused simple hurt to them and thereby committed the offence punishable under section 323 of I.P.C., and within the cognizance of this Court.

Thirdly, on the above said date, time and place, you accused committed criminal intimidation, by threatening to take away the life of CW.1 and that you thereby have committed an offence punishable under section 506 of IPC. and within the cognizance of this Court.

Fourthly, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1, CW.4 and CW.5 members of Scheduled Caste/Tribe, with intent to humiliate them within public view, by abusing them by touching the name of their caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s)

of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the above said date, time and place, you accused not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 506 and 323 of I.P.C. against CW1, CW.4 and CW.5 knowing that they are the members of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
