Aged about 32 years,
R/o Pattedeverahalli village,
Singatagere Hobli,
Kadur Taluk.

as follows:

That you accused No.1 had illicit relationship with you accused No.2, when your relationship was known to husband of you accused No.2 P.S.Suresh, you both did criminal conspiracy to commit murder of husband of you accused No.2 by mixing poison in whisky and keeping the same in front of the house of you accused No.2 so as to show that it was kept in connection with panchayath election in order to consume said whisky by the husband of you accused No.2 and thereby you have

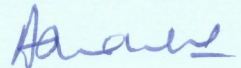
committed criminal conspiracy punishable under section 120-B R/w section 34 of IPC and within my cognizance.

Secondly that on 19.02.2016 at about 6.45 p.m., P.S.Suresh husband of you accused No.2 along with P.B.Suresh, CW.14 and 15 were went to the land of CW.16 in order to consume whisky, but the husband of you accused No.2 P.S.Suresh and another Suresh had consumed the whisky which was mixed with poison and resulting in their death and thereby you have committed the murder of P.S Suresh punishable under section 302 R/w section 32 of IPC and within my cognizance.

Lastly that on 19.02.2016 at about 6.45 p.m., husband of you accused No.2 P.S.Suresh along with P.B.Suresh, CW.14 and 15 were went to the land of CW.16 in order to consume whisky, but husband of you accused No.2 P.S.Suresh and another Suresh were consumed the whisky which was mixed with poison, resulting in their death and thereby you have committed the culpable homicide not amounting to murder of P.B Suresh punishable under section 304 R/w section 32 of IPC and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
