CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

1. Arunkumar E.R. @ Aruna S/o Ramesha,
Aged about 34 years, Coolie, R/o Kasthuri
Hadlu, Kolale village, Narasimharajapura
Taluk, Chikkamagaluru.
2. Priyanka N.S., W/o Aruna E.R., Aged about
34 years, housewife, R/o Kasthuri Hadlu,
Kolale village, Narasimharajapura Taluk,
Chikkamagaluru.
3. Kamalakshi W/o Nagesha, Aged about 55
years, housewife, R/o Kasthuri Hadlu, Kolale
village, Narasimharajapura Taluk,
Chikkamagaluru.

as follows:

That on 16.01.2023, when CW1 Pavithra asked accused No.1
to return the amount, you accused No.1 asked C.W.1 to come near

his house, and on the next day i.e. on 17.01.2023, when C.W.1 went near the house of accused No.1, situated at Kasthuri Hadlu, Kolale village, situated at Narasimharajapura Taluk, coming within the jurisdiction of Balehonnuru Police Station, you accused No.1 in furtherance of common intention, you accused No. 1 to 3 abused CW1 in filthy language and thereby insulted her and provoked her to commit breach of peace and thereby committed the offence punishable under Section 504 r/w Section 34 of I.P.C., and within the cognizance of this Court.

2. That, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of common intention and in the course of the same transaction, you accused No.3 voluntarily caused hurt to CW1, by assaulting her with hands on her person and thereby committed the offence punishable under section 323 r/w Section 34 of I.P.C., within the cognizance of this Court.

3. That, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of common intention and in the course of

the same transaction, you accused No.1 voluntarily caused simple hurt to CW1 by assaulting her with a sickle on her left leg, you accused No.2 assaulted her with a club on her body and hands, and thereby committed an offence punishable under Section 324 r/w Section 34 of I.P.C., within the cognizance of this Court.

4. That, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of the common intention and in the course of the same transaction, you accused No.3 used criminal force on CW1 and dragged her by holding her hand with an intent to outrage her modesty and you thereby committed an offence punishable under section 354 r/w Section 34 of I.P.C., within the cognizance of this Court.

5. That, on the above said date, time and place, you accused No.1 to 3 not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1 Pavithra, member of Scheduled Caste, with intent to humiliate her within public view, by abusing her by touching the name of her caste, and thereby committed the

offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

6. That, on the aforesaid date, time and place, you accused No.1 to 3 not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 324, 354, 504 of I.P.C. against CW1 knowing that she is the member of a Scheduled Caste or a Scheduled Tribe and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
