CHARGE

I, B.Pushpanjali, B.A., LL.M., 1st Addl. District and
Sessions Judge, Chikkamagaluru, do hereby charge you:

1. Sachin Bheemappa Korawar - **split up**
2. Saddam Hussain @ Saddam , S/O.Jilan, Aged 19
years, Tea merchant in Davanagere Railway, R/a 1st
cross, House No.162, Shekarappa Nagar, Kunte,
Davanagere.
3. Siddalingeshwara @ Sidda - **Split up**

as follows:

That on intervening mid night on 15.6.2019 and
16.06.2019 at 0.1.15 AM when CW.1 K.S.Lokesha was standing
at M.G.Circle of Birur, to go to Bhadravathi, you accused No.2
alongwith two other accused came in Tata Indigo car , stopped
the car near CW.1 , asked him to come in their car as they are
going towards Shimoga, accordingly, CW.1 sat in the car of you

accused, and at about 1.45 AM when they reached near Lakkavalli cross, you accused stopped the car, you accused alongwith accused No.2 being seated back seat of the vehicle, showed the knife at CW.1 threatened CW.1 to remove gold and cash, snatched the purse of CW.1 and cash of Rs.200/- kept in it, and tried to snatch gold chain from his neck, when CW.1 made hue and cry, accused No.3 moved the vehicle, you accused No.2 alongwith absconded accused No.1 pushed CW.1 out of the vehicle and voluntarily caused hurt to CW.1 and thereby committed an offence punishable under section 397 of IPC within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said charges.
