C H A R G E

I, Bhanumathi B.C., ., B.A.L, LL.B., II Addl.,
District and Sessions Judge, Chikkamagaluru, do
hereby charge you:-

Aryan Shetty @ Saleem @ Abhishek,
S/o. Mohammad Rafiq, Aged about 25
years, Labourer, R/at. Banglegudde
House, Sadbhavana Nagar,
Kukkunduru village, Karkala Taluk.

as follows:

That you the accused became acquainted with
CW.1-Shreya Shetty through snap chat by name Aryan
Shetty, obtained her mobile number and started
chatting over phone and at that point of time, you
gained information of her caste and education and then
even though you belong to Muslim community, you
concealed the same and disclosed to her that you

belong to Bunts community, to which she belong and you work at Airport Mangaluru and induced her by expressing your love towards her and by promising to marry her and by inducing her so, on 07.01.2023, you accused took her to room No.202 of Grandson lodge situated at Chikkamagaluru city within the jurisdiction of Women Police Station, Chikkamagaluru and therein by promising to marry her, you forcibly committed sexual intercourse with her and similarly, you the accused forcibly committed sexual intercourse with her on several occasions i.e., on 23.01.2023 at Ashvini Lodge, Joga, Shivamogga District, at Sahyadri Comfort, Shivamogga from 31.01.2023 to 02.02.2023 and at room No.206 of said lodge from 04.03.2023 to 05.02.2023, room No.109 of Rajmahal lodge, Chikkamagaluru from 04.02.2023 to 08.02.2023, room No.102 of Navarathna lodge, Chikkamagaluru from 10.02.2023 to 11.02.2023, in a rented house at Ranjadakatte, Thirthahalli Taluk and room No.211 of Adithya Comfort, Kadur on 23.03.2023 and thereby you accused committed an offence of rape punishable under Section 376(2)(n) of Indian Penal Code and within my cognizance.

Secondly, on the aforesaid dates, time and place, you accused by promising to marry CW.1-Shreya Shetty forcibly had sexual intercourse with her for several times and later cheated her by refusing to marry her and thereby you accused committed an offence punishable under section 417 of Indian Penal Code and within my cognizance.

Thirdly, on the aforesaid dates, time and place, you the accused, dishonestly induced CW.1/victim by deceiving to marry her, had sexual relationship with her and thereafter you refused to marry her and thereby committed cheating punishable under section 420 of Indian Penal Code and within my cognizance.

Fourthly, on the aforesaid dates, time and place, you the accused, even though you belong to Muslim community, you concealed the same and disclosed to CW.1 that you belong to Bunts community, to which she belong and you work at Airport Mangaluru and cheated by personation in order to had sexual relationship with her and thereby you committed an punishable under section 419 of Indian Penal Code and within my cognizance.

Lastly, on the aforesaid dates, time and place, you the accused threatened the life of CW.1 with dire consequences and thereby you the accused committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
