as follows:

That you accused Nos. 1 to 7 on 13.06.2015 at about 7.30 p.m., near Vokkaligara Community hall at Kadlemakki village in Balehonnur, with common object, you were being the members of an unlawful assembly to assault C.W.1/Anil and thereby committed an offence punishable under Section 143 r/w. 149 of I.P.C., and within the cognizance of this court.

2. That, you accused 1 to 7 on the aforesaid date, time and place, with common object, being the members of an unlawful assembly armed with deadly weapons committed rioting, with common object of assault to C.W.1 and thereby committed an offence of rioting punishable under section 144, 148 r/w.149 of IPC and within the cognizance of this court.

3. That, you accused 1 to 7 on the aforesaid date, time and place, with common object, wrongfully restrained C.W.1 and thereby committed an offence of wrongful restraint punishable under Section 341 r/w.149 of IPC and within the cognizance of this court.

4. That, you accused Nos. 1 to 7 on the aforesaid date, time and place, with common object, abused C.W.1 in filthy language and thereby insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under section 504 r/w. 149 of I.P.C., and within the cognizance of this court.



That, you accused 1 to 7 on the aforesaid date, time and place, with common object, accused Nos.1 to 3 assaulted with a chopper on the head and hands of C.W.1, you accused Nos. 4 to 6 assaulted with a club all over the body of C.W.1 and thereby committed an offence of attempt to murder punishable under Section 307 r/w.149 of IPC and within the cognizance of this court.

6. That, you accused 7 on the aforesaid date, time and place, with common object, abetted accused Nos.1 to 6 to commit the above said offences to C.W.1 and thereby committed an offence of abetment punishable under Section 109 r/w.149 of IPC and within the cognizance of this court.

7. That, you accused 7 on the aforesaid date, time and place, with common object, harboured accused Nos. 1 to 6 to escape from the place in his vehicle and thereby committed an offence of harbouring punishable under Section 212 r/w.149 of IPC and within the cognizance of this court.

And, I hereby direct that you be tried by this court on the above said charges.


