**CHARGE**

I, K.L.Ashok, B.Com., L.L.B, 1<sup>st</sup> Addl. Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

Suresha, S/o Late Kenchappa, Aged about 34 years, Driver, R/o Kenchikoppa Village, Lakkavalli Hobli, Tarikere Taluk.

as follows:

That on 05.05.2020 at about 8.45 p.m. at Kenchikoppa Village, Tarikere Taluk, coming within the jurisdiction of Lakkavalli Police Station, when CW1 Manjunath was standing in front of his house, at that time, you accused came there and abused CW1 and CW4 Smt.Thungamma in filthy language and thereby insulted them and provoked them to commit breach of peace and thereby committed the offence punishable under section 504 of I.P.C., and within the cognizance of this Court.

*Secondly, on the aforesaid date, time and place, you accused voluntarily caused hurt to CW1 Manjunath by assaulting him with hands on his person and holding his head and buffeting his forehead to the wall and thereby committed an offence punishable under Section 323 of I.P.C. and within the cognizance of this Court.*

*Thirdly, on the aforesaid date, time and place, you accused voluntarily caused hurt to CW1 Manjunath by assaulting him with an arecanut slat on his both legs and thereby committed an offence punishable under Section 324 of I.P.C. and within the cognizance of this Court.*

*Fourthly, on the aforesaid date, time and place, you accused criminally intimidated CW1 Manjunath by giving life threat and thereby committed an offence punishable under Section 506 of I.P.C. and within the cognizance of this court.*

*Fifthly, on the aforesaid date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1 Manjunath, member of Scheduled Caste, with intent to humiliate him within public view, by abusing*

*him by touching the name of his caste, and thereby committed the offence punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.*

*Lastly, on the aforesaid date, time and place, you accused not being the member of Scheduled Castes or Scheduled Tribes, committed offence under Sections 323, 324 and 506 of I.P.C against CW1 Manjunath knowing that he is a member of Scheduled Caste and thereby committed an offence punishable under Sec. 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.*

*And I hereby direct that you be tried by this court on the said charges.*
