C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl., Sessions and
Special Judge, Chikkamagaluru, do hereby charge you:

Rajendra K.R., S/o Ramaiah Gowda,
aged 44 years, Agriculturist, R/at
Koralakoppa, K.Kanaburu Village,
N.R.Pura Taluk.

as follows:

That on 12.3.2023 at about 10.30 a.m, on Koralakoppa – Bilgal mud road at Koralakoppa of K.Kanaburu Village, within the jurisdiction of N.R.Pura Police Station, when CW.2-Krishnamurthy was chatting with CW.3-Vasu, who had come to repair the water jet in the estate of Mallappa Hegde, you accused went there in Omni Car, questioned him as to why he had put poultry manure to the estate and when CW.2 told that he had put the manure at instruction of his owner, you the accused abused him in filthy language and after sometime when you were taking a tractor from your estate, CW.1-Mangalagowri, the wife of CW.2 stopped you and questioned you as to why you had abused her husband and thereby you the accused having abused CW.1 and CW.2 in filthy language knowing fully well that such provocation

would cause them to break the public peace, you committed an offence punishable under section 504 of Indian Penal Code and within my cognizance.

2. That on the aforesaid date, time and place, you accused threatened the life of CW.1 and CW.2 with dire consequences and thereby you the accused committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code and within my cognizance.

3. That on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1, a member of Scheduled Caste with intent to humiliate her within public view and thereby committed the offence punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

4. That on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, abused CW.1, a member of a Scheduled caste by touching the name of her caste within public view and thereby committed the offence punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

5. That on the aforesaid date, time and place, you accused not being the member of any Scheduled Caste or Scheduled Tribe, committed the offence under Section 506 of IPC against CW.1 knowing that she is a member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
