**C H A R G E**

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. Sessions and  
Special Judge, Chikkamagaluru, do hereby charge you:

1. Chethan U.C., S/o Chandrashekar, Aged 32  
years, Agriculturist, R/o Urrumakki,  
Gunavanthe village, Koppa Taluk.
2. Vivekananda B.C. @ Pammi (Abated)

as follows:

That on 11.12.2022 at about 11 p.m. at Urumakki,  
Gunavanthe village, Koppa Taluk within the jurisdiction of  
Koppa Police Station when CW.2-Raju was sleeping on the  
sit out of house of CW.3-Vasu, you accused No.1 and abated  
accused No.2 called CW.2 to come out of the house and when  
CW.2 came out by holding the torch, you accused No.1 and  
abated accused No.2 went to the courtyard of the house and  
abused CW.2 in filthy language and gave provocation,  
knowing fully well that such provocation would cause him to  
break the public peace and that thereby committed an  
offence punishable under section 504 of Indian Penal Code  
r/w Section 34 of said Code and within my cognizance.

2. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and abated accused No.2 assaulted CW.2 with club on his face and head, you accused No.1 hit CW.2 with a stone on his face, made him to fall down and voluntarily caused simple hurt to him and thereby you accused committed an offence punishable under section 324 of Indian Penal Code R/w section 34 of said Code and within my cognizance.

3. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and abated accused No.2 assaulted CW.2 with hands on his person and voluntarily caused simple hurt to him and thereby you accused committed an offence punishable under section 323 of Indian Penal Code R/w section 34 of said Code and within my cognizance.

4. That on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and abated accused No.2 threatened the life of CW.1 with dire consequences and thereby committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code r/w Section 34 of said Code and within my cognizance.

5. That on the above said date, time and place, you accused No.1 and abated accused No.2 not being the members of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.2, a member of a Scheduled Caste by abusing him by touching the name of his caste with intent to humiliate him within public view and thereby committed the offence punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

6. That on the above said date, time and place, you accused No.1 and abated accused No.2 not being the members of any Scheduled Caste or Scheduled Tribe, abused CW.2, a member of a Scheduled Caste by touching the name of his caste within public view and thereby committed the offence punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

7. That on the aforesaid date, time and place, you accused No.1 and abated accused No.2 not being the members of any Scheduled Caste or Scheduled Tribe, committed the offence under Sections 323, 324 and 506 of I.P.C. against CW.2 knowing that he is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
