**CHARGE**

I, K.L.Ashok, B.Com., L.L.B, 1<sup>st</sup> Addl. Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

N.P.Keshava, S/o Parameshwarappa,  
18 years 5 months, R/o Nandi Village,  
Tarikere Taluk.

as follows:

That on 06.05.2020 at about 8.00 a.m. at Gudithopu beedhi, Nandi village, Tarikere Taluk, coming within the jurisdiction of Lingadahalli Police Station, when CW1 Smt.Siddamma in order to collect water went near the public water tap situated in front of the house of you accused, at that time, you accused also went there to collect water and abused CW1 in filthy language and thereby insulted her and provoked her to commit breach of peace

*and thereby committed the offence punishable under section 504 of I.P.C., and within the cognizance of this Court.*

*Secondly, on the aforesaid date, time and place, you accused voluntarily caused hurt to CW1 by dashing your head to CW1's head, by kicking with legs on her chest, by scratching with hands on her chest and thereby committed an offence punishable under Section 323 of I.P.C. and within the cognizance of this Court.*

*Thirdly, on the aforesaid date, time and place, you accused voluntarily caused hurt to CW1 by assaulting him with a concrete piece on her head and thereby committed the offence punishable under Section 324 of I.P.C., and within the cognizance of this Court.*

*Fourthly, on the above said date, time and place, you accused used criminal force on CW1 by holding her chest and pushing her with intent to outrage her modesty and thereby committed an offence punishable under Section 354 of I.P.C. and within the cognizance of this Court.*

*Fifthly, on the aforesaid date, time and place, you accused not being the member of Scheduled Caste or Tribe, intentionally insulted CW1, member of Scheduled Caste, with intent to humiliate her within public view, by abusing her by touching the name of her caste, and thereby committed the offence punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.*

*Sixthly, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, prevented CW1 from using the public water tap and thereby committed the offence punishable under Section 3(1)(za)(A) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.*

*Lastly, on the aforesaid date, time and place, you accused not being the member of Scheduled Castes or Scheduled Tribes, committed offence under Sections 323, 324 and 354 of I.P.C against CW1 knowing that he is the member of Scheduled Tribe and thereby committed an offence punishable under*

*Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act,  
and within the cognizance of this Court.*

*And I hereby direct that you be tried by this Court on the  
said charges.*
