C H A R G E

I, Manjunath Sangreshi, B.A., LL.B., (HONS), II Addl., District and Sessions Judge, Chikkamagaluru, do hereby charge you,

1. Dharmaraj S/o Basavarajappa,
Aged about 23 years, Driver,
R/o Bukkambudi village, Ajjampura Taluk.

2. Suvarnamma D/o Basavarajappa,
Aged about 46 years, Housewife,
R/o Bukkambudi village, Ajjampura Taluk.

3. Basavarajappa S/o Channa,
Aged about 54 years, Coolie,
R/o Bukkambudi village, Ajjampura Taluk.

4. Bhuvanesh S/o Basavarajappa,
Aged about 24 years, Student,
R/o Bukkambudi village, Ajjampura Taluk.

as follows:

That in Bukkambudi village, within the jurisdiction of Ajjampura Police Station, you accused No.1 married the deceased Smt.Latha at Kallathagiri without the knowledge of her parents and after the marriage the deceased was residing with you, thereafter, you all the accused subjected Smt.Latha to physical and mental cruelty in connection with your demand for Rs.50,000/- to purchase auto and for residing at Tumakuru and you accused No.2 to 4

administered poison and kept her at Temple and thereby committed the offence punishable under section 498-A R/w section 34 of IPC and within cognizance of this Court.

That in between 19.04.2019 night at about 10.00 p.m. and on 20.05.2019 at about 06.00 a.m., in your house at Bukkambudi village, with an intention to commit murder of Smt.Latha, you accused No.1 assaulted Smt.Latha, after assaulting her, attempted to hang her with a plastic rope, as the plastic rope did not withstand her weight, hanged her with veil and committed murder of Smt.Latha and thereby you accused committed the offence punishable under section 302 R/w section 34 of IPC and within cognizance of this Court.

That on the above said date, time and place, you accused committed the murder of Smt.Latha, within seven years of her marriage with you accused No.1 and soon before her death, you accused subjected her to cruelty and thereby you accused have committed the offence dowry death punishable under section 304-B R/w section 34 of IPC and within cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
