C H A R G E

I, Bhanumathi B.C., B.A.L, LL.B., I Addl., Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

1. Jayapal @ Jayapala @ Jayapala K.R.,
S/o Ramegowda K.A., Aged 56 years,
Agriculturist,
2. Sudeesha @ Sudeesha K.G., S/o
Jayapala K.R., Aged 29 years,
Both are R/o Ambedkar Nagara,
Kunnalli village, Halase Post, Mudigere
Taluk.

as follows:

That on 02.05.2023 in between 9 a.m. and 10 a.m. at Kunnahalli village, Mudigere Taluk within the jurisdiction of Mudigere Police Station, when CW.1-Mahabala was proceeding on the mud road in the land belonging to CW7 Dharmapala @ Papanna, you accused No.1 and 2 with common intention, obstructed him from proceeding further in a direction in which he had every right to proceed and thereby you the accused committed an offence punishable under section 341 of Indian Penal

Code r/w Section 34 of said Code and within my cognizance.

Secondly, on the aforesaid date, time and place, you accused No.1 and 2 in furtherance of your common intention, abused CW1 in filthy language and gave provocation, knowing fully well that such provocation would cause him to break the public peace and that thereby committed an offence punishable under section 504 of Indian Penal Code r/w Section 34 of said Code and within my cognizance.

Thirdly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 assaulted CW.1 with hands on his back and neck and you accused No.2 kicked CW.1 on his waist and voluntarily caused simple hurt to him and thereby you accused committed an offence punishable under section 323 of Indian Penal Code R/w section 34 of said Code and within my cognizance.

Fourthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and 2 threatened the life of CW.1 with dire consequences and thereby committed an offence of criminal intimidation punishable under section 506 of Indian Penal Code r/w. Section 34 of said Code and within my cognizance.

Fifthly, on the above said date, time and place, you accused No.1 and 2 not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1, a member of a Scheduled Tribe by

abusing him by touching the name of his caste with intent to humiliate him within public view and thereby committed the offences punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

Sixthly, on the above said date, time and place, you accused No.1 and 2 not being the members of Scheduled Caste or Scheduled Tribe, abused CW1, a member of a Scheduled Tribe by touching the name of his caste within public view and thereby committed the offences punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

Lastly, on the aforesaid date, time and place, you accused No.1 and 2 not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 341, 323 and 506 of I.P.C. against CW1 knowing that he is the member of a Scheduled Tribe and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
