as follows:

That in Sakharayapattana village, within the limits of Sakharayapattana Police Station, you accused No.2 being the wife of complainant had illicit relationship

with you accused No.1 and with an intention to kill the complainant, who is obstacle to your illicit relationship, did criminal conspiracy and both of you hatched conspiracy to do away the life of complainant and thereby you committed an offence punishable under section 120-B of Indian Penal Code R/w section 34 of said Code and within my cognizance.

2. That on the night of 21.02.2019 at about 11.30 p.m., you accused Nos.1, 3 to 8 with common intention of committing offence, came near the house of complainant situated in Sakharayapattana Village in Car bearing No.KA.18/Z-2425 and with common object formed yourselves into an unlawful assembly and thereby you accused committed an offence punishable under section 143 R/w section 149 of Indian Penal Code and within my cognizance.

3. That on the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of an unlawful assembly by holding deadly weapons came near the house of CW.1 and thereby you accused committed an offence punishable under section 144 R/w section 149 of Indian Penal Code and within my cognizance.

4. That on the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of unlawful assembly and in furtherance of the common object of said assembly committed rioting by holding deadly weapons and thereby you accused committed an offence punishable under section 148 R/w section 149 of Indian Penal Code and within my cognizance.

5. That on the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of unlawful assembly and in furtherance of the common object, committed house trespass by entering into the house of CW.1, used as a human dwelling in order to commit the offence and thereby you accused committed an offence punishable under section 450 of Indian Penal Code R/w section 149 of said Code and within my cognizance.

6. That on the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of unlawful assembly and in furtherance of the common object, after preparation made for causing death of the complainant, damaged the window glass of the house of complainant and glass of his car and caused mischief to the tune of Rs.500/- and thereby you accused committed an offence punishable under section 440 of Indian Penal Code R/w section 149 of said Code and within my cognizance.

7. On the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of unlawful assembly and in furtherance of the common object, you accused abused CW.1 in filthy language, gave provocation to him knowing fully well that such provocation would cause him to break the public peace and thereby you accused committed an offence punishable under section 504 of Indian Penal Code R/w section 149 of said Code and within my cognizance.

8. That on the aforesaid date, time and place, you accused in furtherance of your common intention to commit the murder of CW.1 and with a knowledge that

by your act you would be causing death of CW.1 and under circumstances in which by your act CW.1 had died, you would have been guilty of murder, you accused No.1 swung Iron Long on the head of CW.1, but CW.1 escaped by going into the house and locking the door of his house and thereby you the accused committed an offence punishable under section 307 of Indian Penal Code R/w Section 149 of said Code and within my cognizance.

9. That on the aforesaid date, time and place, you accused Nos.1, 3 to 8 being the members of unlawful assembly and in furtherance of the common object, committed criminal intimidation by threatening CW.1 with injury to his person and thereby you the accused committed an offence punishable under section 506 of Indian Penal Code R/w section 149 of said Code and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
