CHARGE

I, Bhanumathi B.C., B.A.L, LL.B., I Addl. Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

- A1. Nandini W/o Somashekar,
Aged about 30 years,
- A2. Somashekar, S/o Ramappa,
Aged about 35 years,
- A3. Ramesh P.J S/o Jayappa,
Aged about 43 years,
- A4 Vanitha R/o Ramesh P.J,
Aged about 41 years,
- A5 Sumithramma @ Savithramma,
W/o Jayanna,
Aged about 45 years,

All are residing at Amruthapura,
Emmedoddi village, Birur Hobli,
Kadur Taluk.

as follows:

That on 26.03.2025 at about 5.00 p.m, when CW.1-Kumara was digging trench by the side of the land belonging his elder aunt Ammaiah bearing Sy.No.70/P situated at Emmedoddi Rangenahalli village, Birur Hobli, Kadur Taluk within the jurisdiction of Kadur police station

with a JCB belonging to CW.7-Madan, you accused No.1, 3 to 5 obstructed said work and then you accused No.1 to 5 formed yourselves into an unlawful assembly with common object of committing an offence and thereby you accused committed an offence punishable under section 189(2) of Bharatiya Nyaya Sanhita 2023 and within my cognizance.

2. Secondly, on the aforesaid date, time and place, in the course of same transaction, being the members of unlawful assembly in furtherance of its common object, you accused No.1 to 5 abused CW.1 and his wife CW.4-Sakamma in filthy language knowing fully well that such provocation would cause them to break the public peace and thereby you accused committed an offence punishable under section 352 of Bharatiya Nyaya Sanhita 2023 r/w section 190 of said Sanhita and within my cognizance.

3. Thirdly, on the aforesaid date, time and place, in the course of same transaction, being the members of unlawful assembly in furtherance of its common object, you accused No.1 to 5 issued threat to the lives of CW.1 and CW.4 and thereby you committed an offence of criminal intimidation punishable under section 351(3) of Bharatiya Nyaya Sanhita 2023 r/w section 190 of said Sanhita and within my cognizance.

4. Fourthly, on the aforesaid date, time and place, you accused No.1 to 5 not being the members of any Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1 and CW.4, the members of a Scheduled Caste with intent to humiliate them within public view and thereby you accused committed the offence punishable under Section 3(1)(r) of the SC & ST (Prevention of Atrocities) Amendment Act, 2015 and within my cognizance.

5. Fifthly, on the aforesaid date, time and place, you accused No.1 to 5 not being the members of any Scheduled

Caste or Scheduled Tribe, abused CW.1 and CW.4, the members of a Scheduled Caste by touching the name of their caste within public view and thereby you accused committed the offence punishable under Section 3(1)(s) of the SC & ST (Prevention of Atrocities) Amendment Act, 2015 and within my cognizance.

6. Lastly, on the aforesaid date, time and place, you accused No.1 to 5 not being the members of any Scheduled Caste or Scheduled Tribe, committed the offence under sections 189(2) and 351(3) of Bharatiya Nyaya Sanhita 2023 (corresponding to sections 143 and 506 of Indian Penal Code) against CW.1 and CW.4 knowing that they are the members of a Scheduled Caste and thereby you accused committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Amendment Act, 2015 and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
