**C H A R G E**

I, Bhanumathi B.C., B.A.L, LL.B., II Addl.,  
District and Sessions Judge, Chikkamagaluru, do  
hereby charge you:

1. Kariyappa S/o. Late Kambanna,  
Aged 56 years, Agriculturist, R/a  
Arabala Gollarahatti village,  
Ajjampura Taluk.
2. Manjunatha, S/o. Kariyappa, Aged 23  
years, Agriculturist, R/a Arabala  
Gollarahatti village, Ajjampura  
Taluk.
3. Smt.Geethamma, W/o.Kariyappa,  
Aged 50 years, Agriculturist, R/a  
Arabala Gollarahatti village,  
Ajjampura Taluk.

as follows:

That on 19.01.2020 at about 1.30 PM at Arabala Gollarahatti village, Ajjampura Taluk situated within the jurisdiction of Ajjampura police station when you accused No.1 and 2 were throwing the garbage towards the wall of the house of CW.1, which was mixed with the sheep manure, CW.1 and CW.2 asked you accused not to throw the waste towards the wall of their house, then you accused in furtherance of your common intention, picked up quarrel with them, abused them in filthy language uttering “ಬೇವರ್ಸಿ ಮುಂಡೆ ಹಲ್ಕಿ ಮುಂಡೆ” gave provocation, knowing fully well that such provocation would cause them to break the public peace and thereby you the accused committed an offence punishable under section 504 of Indian Penal Code R/w. Section 34 of Indian Penal Code and within my cognizance.

Secondly, on the aforesaid date, time and place you accused in furtherance of your common intention to commit the murder of CW.1 Smt.Gowramma, and CW.2 Kumarappa and with a knowledge that by your act you would be causing death of CW.1 and CW.2 and under circumstances in which by your act CW.1 and CW.2 had died, you would have guilty of murder, you accused No.1 assaulted on the head of CW.1 with a club and on her person and you accused No.3 assaulted CW.2 with a bamboo stick below the neck and caused simple injuries and attempted to commit murder of CW.1 and CW.2 and thereby you the accused committed an offence punishable

under section 307 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

Thirdly, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention voluntarily caused simple injuries to CW.1 and CW.2 by assaulting them with a club and bamboo stick on their person and that you have committed an offence punishable under section 324 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

Fourthly, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention, voluntarily caused simple hurt to CW.1 and CW.2 by dragging them and assaulting them with hands on their person and that you have committed an offence punishable under section 323 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

Lastly, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention, you accused No.1 and 2, dragged CW.1 Smt.Gowramma, assaulted on her person, tried to outraged her modesty and that you thereby have committed an offence punishable under section 354 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
