as follows:

That on 08-03-2013 at about 7.00 p.m., near Shadimahahal in Chikkamagaluru city, you all accused in prosecution of common object of which was to commit murder of CW.1 to 7, formed an unlawful assembly and thereby committed the offence of member of an unlawful assembly punishable under Sections 143 R/w Sec. 149 of I.P.C., and within my cognizance.

Secondly, on the aforesaid date, time and place, in furtherance of common object you accused by holding deadly weapons committed rioting and thereby committed the offence rioting punishable under Sections 147 R/w Sec. 149 of I.P.C., and within my cognizance.

Thirdly, on the aforesaid date, time and place, in furtherance of common object, you accused No.1 assaulted CW.4 behind his neck, hands and elbow with long, caused simple injuries and also assaulted CW.7 on his lips, shoulder and right knee with long, caused simple injuries, you accused No.2 assaulted C.W.5 on his left elbow with long voluntarily caused simple, you accused No.3

assaulted CW.7 on his nose and shoulders with long, caused injuries, you accused No.4 assaulted CW.6 on his head, left shoulder and hands and legs with an iron rod, voluntarily caused simple injuries, you accused No.5 assaulted CW.6 on his back and left ear with long, caused injuries, you accused No.6 assaulted CW.4 on his head, hands and legs with a club, caused simple injuries and you accused No.7 assaulted CW.3 on his left side head and behind neck, voluntarily caused injuries and thereby you have committed an offence punishable under section 324 R/w Sec.149 of I.P.C and within my cognizance.

Fourthly, on the aforesaid date, time and place, in furtherance of common object, you accused No.1 assaulted CW.4 behind his neck, hands and elbow with long, caused grievous injuries and also assaulted CW.7 on his lips, shoulder and right knee with long, and caused grievous injuries, you accused No.2 assaulted on his left elbow with the help of long and caused grievous injuries, you accused No.3 assaulted CW.7 on his nose and shoulders with long, and caused injuries, you accused No.4 assaulted CW.6 on his head, left shoulder and hands and legs with an iron rod, voluntarily and caused grievous injuries and thereby you have committed an offence punishable under section 326 R/w Sec.149 of I.P.C and within my cognizance.

Fifthly, on the aforesaid date, time and place, you accused in furtherance of common object committed criminal intimidation by giving life threat to C.W.1 to 7 and thereby committed an offence of criminal intimidation punishable under Section 506 R/w Sec.149 of I.P.C., and within my cognizance.

Lastly, on the aforesaid date, time and place, in furtherance of common intention of you A-1 to A-7, assaulted CW 1 to 7 with the club, long and iron rods caused simple and grievous injuries, with intention to commit murder of them you would have been guilty of murder, and that you thereby caused hurt to them and committed an offence punishable under Section 307 read with Section 149 of I.P.C and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.

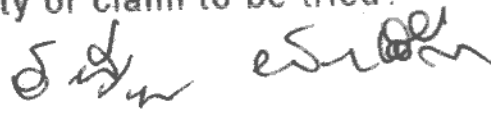
