CHARGE

I, K.L.Ashok, B.Com., LL.B, 1st Addl. Dist. & Sessions Judge,
Chikkamagaluru, do hereby charge you:

Prasanna K.V., S/o K.N.Venkatappa Gowda,
Aged 47 years, Farmer, R/o Kolale Village,
Megaramakki Post, N.R.Pura Taluk,
Chikkamagaluru District.

as follows:

That on 18.06.2019 at about 5.15 p.m. at Kolale Village,
N.R.Pura Taluk, within the jurisdiction of Balehonnur Police Station,
when you accused was leveling the encroached forest land at Sy.No.125,
CW5 Nagaraj, Tahsildar and CW6 Shivamurthy, Village accountant,
informed the same to CW1 Shivakumar P., forest guard and when CW1
came there, stopped you and informed the same to his superiors, at that
time, you accused wrongfully restrained him from proceeding further
and thereby committed the offence punishable under Section 341 of
I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, place and time, you accused, abused CW1 Shivakumar P. in filthy language and thereby insulted him and provoked him to commit breach of peace and thereby committed the offence punishable under section 504 of I.P.C., and within the cognizance of this Court.

Thirdly, on the above said date, place and time, you accused, voluntarily caused hurt to CW1 Shivakumar P. by assaulting him with hands on his body and kicking with leg on his stomach, in order to prevent him from discharging his duty as a public servant and thereby committed the offences punishable under section 323 and section 332 of I.P.C., and within the cognizance of this Court.

Fourthly, on the above said date, time and place, you accused used criminal force to CW.1 Shivakumar P. by assaulting him with hands, kicking with legs, pulling his shirt collar and removing his shirt buttons, to deter a public servant from discharging his duty and thereby committed an offence punishable under Section 353 of I.P.C., and within the cognizance of this court.

Fifthly, on the aforesaid date, time and place, you accused criminally intimidated CW.1 Shivakumar P. by giving life threat and

thereby committed an offence punishable under Section 506 of I.P.C. and within the cognizance of this court.

Sixthly, on the above said date, time and place, you accused not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1 Shivakumar P. member of Scheduled Caste, with intent to humiliate him within public view, by abusing him by touching the name of his caste, and thereby committed an offence punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused not being the member of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 332 and 506 of I.P.C. against CW.1 Shivakumar P. knowing that such person is a member of a Scheduled Caste or a Scheduled Tribe and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
