CHARGE

I, K.L.Ashok, B.Com., LL.B, 1st Addl. Dist. & Sessions Judge,
Chikkamagaluru, do hereby charge you:

1. Manjunatha @ Manju @ Manjunatha C.N.,
S/o Nagaraj, Aged about 20 years, Labourer,
2. Nagaraj, S/o Ramaswamy, Aged about 40
years, Labourer,
3. Smt.Geetha, W/o Nagaraj, Aged about 37
years, Labourer,
4. Kum.Rekha, D/o Nagaraju, Aged about 21
years, Labourer,

All are R/o Ashraya Mane Badavane,
Kalyana Nagara, Jyothinagara Post,
Chikkamagaluru Town.

as follows:

That on 22.05.2019 at about 9.00 p.m. at Ashraya Mane
Badavane, Kalyana Nagara, Chikkamagaluru Town, coming within
the jurisdiction of Town Municipality, Chikkamagaluru, when
CW1-Kum.Vinitha was standing in front of the house of CW4

Anthonyamma (mother of CW1), at that time, you accused No.1 to 4 with common intention came there and abused CW1 in filthy language with regard to lodging of police complaint against you accused persons and thereby insulted her and provoked her to commit breach of peace and thereby committed the offence punishable under Section 504 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, place and time, in furtherance of your common intention, you accused No.1 voluntarily caused hurt to CW1 Kum.Vinitha by dragging her hairs, assaulting her with hand, you accused No.2 voluntarily caused hurt to CW1 by kicking with legs on her stomach, you accused No.3 and 4 voluntarily caused hurt to CW1 by holding her neck and assaulting with hands on her person and thereby committed the offence punishable under section 323 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Thirdly, on the above said date, time and place, in furtherance of your common intention, you accused persons used criminal force and assaulted to CW.1 Kum.Vinutha with intent to disrobe her and thereby committed an offence punishable under

Section 354B r/w Section 34 of I.P.C. and within the cognizance of this court.

Fourthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused persons criminally intimidated CW.1 Kum.Vinutha by giving life threat and thereby committed an offence punishable under Section 506 r/w Section 34 of I.P.C. and within the cognizance of this court.

Fifthly, on the above said date, time and place, you accused Nos.1 to 4 not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW.1 Kum.Vinutha, member of Scheduled Caste, with intent to humiliate her within public view, by abusing her by touching the name of her caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Sixthly, on the above said date, time and place, you accused persons not being the members of Scheduled Caste or Scheduled Tribe, intentionally touched CW.1 Kum.Vinutha, member of Scheduled Caste, knowing that she belongs to a Scheduled Caste

and thereby committed the offence punishable under Section 3(1) (w)(i) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused persons not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 354B and 506 of I.P.C. against CW.1 Kum.Vinutha knowing that she is the member of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
