CHARGE

I, D.Kambegowda, B.A.L., LL.B., II Addl. Sessions Judge,
Chikmagalur, do hereby charge you:

1. Santhosh S/o late Ramanna,
Aged about 28 years, Driver,
R/o Near Tilak Park Road,
Vijayapura Extension,
Chikkamagaluru city,
N/o. Mallenahalli, Chikkamagaluru Taluk.
2. Smt.Savithramma W/o late Ramanna,
Aged about 62 years, Coolie,
R/o Behind Harsha Furniture,
Near Tilak Park, Chikkamagaluru,
N/o. Mallenahalli, Chikkamagaluru Taluk.

as follows:

That you, the accused No.1, being the husband and you
accused No.2 being the mother-in-law of the deceased Smt.Anitha,
after the marriage of Smt.Anitha with you accused No.1, in your
rented house, situated near Tilak Park, Vijayapura Extension,

Chikkamagaluru city, with common intention, quarreled with her alleging that she was not prepared non-vegetarian dishes and subjected her to mental and physical cruelty by demanding more dowry from her parents and thereby you have committed an offence punishable under Section 498-A R/w Section.34 of I.P.C., and within my cognizance.

Secondly, that you, both the accused being the husband and mother in law of Smt.Anitha, at the time of marriage of Smt.Anitha, received gold ornaments from her parents and not returned the same to them and thereby you have committed an offence punishable under section 3 of Dowry Prohibition Act and within my cognizance.

Thirdly, that you, both the accused being the husband and mother in law of Smt.Anitha, after the marriage of Smt.Anitha, demanded more dowry from the deceased Smt.Anitha and quarreled with her and thereby you have committed an offence punishable under section 4 of Dowry Prohibition Act and within my cognizance.

Fourthly, that you accused No.1 on 24.02.2016 at about 6.00 p.m., came by consuming alcohol kicked on the stomach of your wife Smt.Anitha, assaulted on her by your hands and legs, alleging that she has not prepared non-vegetarian dishes and not brought

dowry, caused pain and thereby committed an offence punishable under section 323 of I.P.C and within my cognizance.

Fifthly, that you accused No.1 on the above said date, time and place came by consuming alcohol kicked on the stomach of your wife Smt.Anitha, assaulted on her by your hands and legs, alleging that she has not prepared non-vegetarian dishes and not brought dowry, caused pain & bleeding, admitted her to Govt Hospital, Chikkamagaluru, her baby died in the womb, caused death of quick unborn child by act amounting to culpable homicide and thereby committed an offence punishable under section 316 of I.P.C and within my cognizance.

Lastly, both of you, the accused being the husband and mother-in-law of Smt. Anitha, forced and demanded the deceased Smt.Anitha to bring dowry, on 24.02.2016 at about 6.00 p.m., you accused No.1 came by consuming alcohol kicked on her stomach, assaulted on her by your hands and legs, alleging that she has not prepared non-vegetarian dishes and not brought dowry, caused pain & bleeding, admitted her to Govt Hospital, Chikkamagaluru, her baby died in the womb due to bleeding and shifted to Hassan HIMS Hospital, and further shifted to Victoria Hospital, Bengaluru, on 27.02.2016 at about 10.00 p.m., she died in the Victoria Hospital due to severe bleeding and the said death is dowry death, within seven years of her marriage and that soon before her death, she was subjected by both of you and thereby committed an offence

punishable under section 304-B R/w Section. 34 of I.P.C. and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
