C H A R G E

I, Manjunath Sangreshi, B.A., LL.B., (HONS), II Addl., District
and Sessions Judge, Chikkamagaluru, do hereby charge you,

Kirankumar S/o Thimmegowda,
Aged about 29 years, Auto Driver,
R/o Thadabenahalli village,
Uddeboranahalli Post,
Chikkamagaluru Taluk.

as follows:

That in rented house of one Krishnamurthy, Uddeboranahalli
village, within the limits of Sakharayapattana Police Station, you
accused being the husband of CW.1 Smt.Pallavi, after your marriage,
suspecting the character of your wife, started to harass her both
physically and mentally and thereby subjected the said CW.1
Smt.Pallavi to cruelty and thereby committed the offence punishable
under section 498-A of IPC and within the cognizance of this Court.

Secondly, that on 01.06.2016 at about 8.15 p.m., when CW.1
was feeding milk to her child by sleeping on the cot in your rented

house, you came there abused her in filthy language and gave provocation to her intending or knowing it to be likely that such provocation will cause to break public peace and thereby committed the offence punishable under section 504 of IPC and within the cognizance of this Court.

Thirdly, that on the above said date, time and place, you accused pulled legs of your wife Smt.Pallavi, dashed her head to the ground by holding her hairs and caused injuries to her body and thereby committed the offence punishable under section 323 of IPC and within the cognizance of this Court.

Lastly, that on the above said date, time and place you accused assaulted CW.1-Smt.Pallavi and committed criminal intimidation by threatening CW.1 with injury to her person and caused alarm to her and thereby you have committed an offence punishable under section 506 of IPC and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
