C H A R G E

I, Manjunath Sangreshi, B.A., LL.B., (HONS), II Addl., District
and Sessions Judge, Chikkamagaluru, do hereby charge you,

1. Supreeth Praveen Kumar @ Supreeth,
S/o Huchegowda, Aged about 34 years, Engineer
R/o Lakshmishanagar, 1st Cross,
Chikkamagaluru.

2. Smt. Geetha S/o Huchegowda,
Aged about 58 years,
R/o Lakshmishanagar, 1st Cross,
Chikkamagaluru.

3.Sri Huchegowda H.D., S/o late Doddegowda,
Aged about 70 years,
R/o Lakshmishanagar, 1st Cross,
Chikkamagaluru.

4. Smt. Sheela S/o Chandrashekar,
Aged about 36 years, Housewife,
R/o Vinobhanagara, 1st Cross,
Shivamogga.

as follows:

That you accused No.1 being the husband and you accused No.2 and 3 being the in-laws of CW.1 Smt.Kavyashri on the instigation of you accused No.4 being the sister-in-law of CW.1, with the common intention, after her marriage, in your house at Lakshmishanagara, Chikkamagaluru city, within the jurisdiction of Women P.S., Chikkamagaluru, by demanding dowry, have physically and mentally harassed her and thereby subjected the said CW.1 Smt.Kavyashree to cruelty and thereby committed the offence punishable under section 498-A of IPC R/w section 34 of IPC and within the cognizance of this Court.

Secondly, that on 27.09.2017 in the afternoon, in your house at Lakshmishanagar, Chikkamagaluru city, within the limits of Women P.S., you accused No.1 to 3, on the instigation of you accused No.4, in furtherance of your common intention, abused CW.1 Smt.Kavyashree in filthy language and gave provocation to her intending or knowing it to be likely that such provocation will cause to break public peace and thereby committed the offence punishable under section 504 R/w section 34 of IPC and within the cognizance of this Court.

Thirdly, that on the above said date, time and place, on the instigation of you accused No.4, in furtherance of your common intention, you accused No.2 voluntarily assaulted CW.1 Smt.Kavyashree with your hands on her chest, back and all over body and caused injuries to her body and thereby committed the offence punishable under section 323 R/w section 34 of IPC and within the cognizance of this Court.

Fourthly, that on the above said date, time and place you accused No.2 and 3 on the instigation of you accused No.4, in furtherance of your common intention assaulted Kavyashree with hands and hot knife and committed criminal intimidation by threatening CW.1 with injury to her person saying that if she died you will perform another marriage to accused No.1 and caused alarm to her and thereby you have committed an offence punishable under section 506 R/w 34 of IPC and within the cognizance of this Court.

Fifthly, that on the above said date, time and place you accused No.2 and 3 with an intention to kill CW.1 Kavyashree, you you accused No.2 hold the hands of C.W1 tightly, accused No. 3 took the knife and got heated it on the gas stove and put on her left and right leg, burnt the same on CW.1. Thereafter when CW.1 made hue and cry, you accused No.3 took the wire of mobile charges, tied it around the neck of CW.1 tightly saying that if she died they will perform another marriage to their son/you accused No.1, with such intention or knowledge and under such circumstances that by that act you had caused the death of Smt. Kavyashree, you would have been guilty of murder and that you have committed an offence punishable under section 307 of IPC R/w section 34 of IPC and within the cognizance of this Court.

Sixthly, you all the accused, at the time of marriage of Kavyashree received 500 gram gold from the parents of Kavyashree and thereby you have committed an offence punishable under section 3 of Dowry Prohibition Act and within the cognizance of this Court.

Seventhly, you all the accused after the marriage of Kavyashree demanded dowry from Kavyashree and her parents and thereby you have committed an offence punishable under section 4 of Dowry Prohibition Act and within the cognizance of this Court.

Lastly, that on the above said place you accused No.4 with an intention to kill CW.1 Kavyashree, instigated/abetted you accused No.1 to 3 to commit the above said offences and thereby you have committed an offence punishable under section 114 R/w 34 of IPC and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
