as follows:

That on 28.10.2015 night at 10.00 p.m., you accused Nos.1 to 5 came in a Maruthi Ertiga car bearing No.KA-17/B-6860 near the house of complainant Prasad K.Nair situated at Mathimara-Bale village in N.R.Pura Taluk, when the complainant was sleeping in his house, dogs were barking, he wake up and opened the door, you accused Nos.4 and 5 were came near the door, enquired about the price of rubber saplings and asked water. When the complainant went inside to bring water, you accused Nos.2 to 5 entered into his house, demanded money, you accused No.3 assaulted him with long on his fore-head and left forearm caused bleeding injury, you accused Nos.1 and 2 took away a TV and L.G computer, you accused No.5 took two current induction stoves and you accused No.6 give the above said vehicle to the custody of you accused Nos.1 to 5 to commit dacoity and thereby you have conjointly committed an offence of dacoity, punishable under section 395 of the I.P.C and within my cognizance.

And I hereby direct that you be tried by this court on the above said charges.
