CHARGE

I, K.L.Ashok, B.Com., LL.B, 1st Addl. Dist. & Sessions
Judge, Chikkamagaluru, do hereby charge you:

1. Jagannatha Naidu, S/o Late Muniswamy,
Aged about 53 years, Agriculturist,
2. Ramachandra Naidu, S/o Late Muniswamy,
Aged about 61 years, Agriculturist,
3. Nagaraja V @ Nagaraja Naidu, S/o Late
Muniswamy, Aged about 55 years,
Agriculturist.
4. Dharaniyamma, W/o Ramachandra Naidu,
Aged about 51 years, House wife,
All are R/o Bavikere Village, Lakkavalli
Hobli, Tarikere Taluk.

as follows:

That on 01.07.2019 at about 2.00 p.m. at Duglapura
Village, Tarikere Taluk, coming within the jurisdiction of Tarikere
Police Station, when CW1 Dhanalakshmi, CW2 Ankamma, CW3

Radharani, CW4 Baby and CW5 Harish after performing the pooja were plaining the plants in the land bearing Sy.No.86/P/84 belonging to CW2, at that time, you accused No.1 to 4 with common intention, committed criminal trespass by entering into the said land with intent to commit an offence and thereby committed the offence punishable under section 447 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Secondly, on the above said date, place and time, in furtherance of your common intention, you accused No.1 to 4 abused CW1 Dhanalakshmi and CW2 Ankamma in filthy language and thereby insulted them and provoked them to commit breach of peace and thereby committed the offence punishable under section 504 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Thirdly, on the above said date, place and time, in furtherance of your common intention, you accused No.1 voluntarily caused hurt to CW2 Ankamma by assaulting her with hands on her person and you accused No.2 voluntarily caused hurt to CW1 Dhanalakshmi by assaulting her with hand on her

left ear and pushing her towards a saguvani tree causing injury to her head and waist and thereby committed the offence punishable under section 323 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused No.1 and 2 used criminal force on CW1 Dhanalakshmi and CW2 Ankamma with intent to outrage their modesty and thereby committed an offence punishable under Section 354 r/w Section 34 of I.P.C., within the cognizance of this Court.

Fifthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused persons criminally intimidated CW1 Dhanalakshmi and CW2 Ankamma by giving life threat and thereby committed an offence punishable under Section 506 r/w Section 34 of I.P.C. and within the cognizance of this Court.

Sixthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused persons committed mischief and caused loss by removing the plants

planted by CW1 to CW5 and thereby committed an offence punishable under Section 427 r/w Section 34 of I.P.C. and within the cognizance of this Court.

Seventhly, on the above said date, time and place, you accused No.1 to 4 not being the members of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1 Dhanalakshmi and CW2 Ankamma, members of Scheduled Caste, with intent to humiliate them within public view, by abusing them by touching the name of their caste, and thereby committed the offences punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Eighthly, on the above said date, time and place, you accused No.1 to 4 not being the members of Scheduled Caste or Scheduled Tribe, intentionally touched CW1 Dhanalakshmi and CW2 Ankamma, members of Scheduled Caste, knowing that they belong to a Scheduled Caste and thereby committed the offence punishable under Section 3(1)(w)(i) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Ninethly, on the above said date, time and place, you accused No.1 to 4 not being the members of Scheduled Caste or Scheduled Tribe, destroyed the plants in the land belonging to CW2 Ankamma, member of Scheduled Caste and thereby committed the offence punishable under Section 3(1)(g) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused No.1 to 4 not being the members of Scheduled Castes or Scheduled Tribes, committed the offence under Sections 323, 354, 447 and 506 of I.P.C. against CW1 Dhanalakshmi and CW2 Ankamma knowing that they are the members of a Scheduled Caste and thereby committed an offence punishable under Section 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.
