I, Manjunath Sangreshi., B.A., LL.B.,(HONS), II Addl., District and
Sessions Judge, Chikkamagaluru, do hereby charge you,

Lingaraju @ Ningaraju @ Lingaraja
Echalakatti, S/o Megharaj,
Aged about 26 years, Police Constable,
CAR Bengaluru,
R/o Alaboora village, Kogali Hobli,
Kotturu Taluk, Bellary District.

as follows:

That you accused having illicit relationship with CW.7-
Smt.Reshma since three years and have a female baby by name Amisha
from the said relationship. Thereafter, CW.7 used to torture you
accused by threatening to inform your illicit relationship to public and
family of you, demanded money and hence you thought that if you had
finished your daughter i.e., Amisha, then CW.7 would not black mail
you. Further on 03.08.2019 night at about 12.00 p.m., in Coolie Line
of Sudhir Coffee Estate, Joldal Palya village, within the jurisdiction of
Mallandur Police Station, with an intention to commit murder of said
child, you accused, administered the alcohol to CW.7 with an intention

to commit the offence and thereby committed the offence punishable under section 328 of IPC and within the cognizance of this Court.

That on the above said date, time and place, with an intention to commit murder of Amisha, you had drunk with CW.7 in her house and while CW.7 had been to attend nature call, you forcibly pressed the mouth of said Amisha with your hand and murdered her by suffocation and thereby committed the offence punishable under section 302 of IPC and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
