C H A R G E

I, Manjunath Sangreshi., B.A., LL.B.,(HONS), II Addl., District and
Sessions Judge, Chikkamagaluru, do hereby charge you,

1. Munavar Pasha @ Munna,
S/o Chand Pasha, Aged about 19 years,
R/o D.No.2263, 4th Cross, L.B.Shasthri Nagar,
HAL, Bengaluru.

2. Manju @ Manjunatha @ Manja,
S/o Seenappa V, Aged about 35 years,
Murugeshapalya, Bengaluru city,
Permanent at Doddur Karapanahalli village,
Bemel, Bangarapete Taluk, Kolar.

as follows:

That on 01.11.2015 at about 11.30 a.m at Panchanahalli village,
within the limits of Panchanahalli P.S., Kadur Taluk, when CW.1
Ravikumar was in his cloth shop, accused No.1 at the instigation of
you accused No.2 with the common intention to commit murder of
CW.1, picked up quarrel with CW.1 and abused him in filthy language
by stating that 'Soolemagane' and gave provocation to CW.1 intending
or knowing it to be likely that such provocation will cause to break
public peace and committed the offence punishable under section 504
R/w section 34 of IPC and within my cognizance.

Secondly, that on the above said date, time and place you accused No.2 being the abettor, present at the time of commission of offence committed by you accused No.1 and that you have committed an offence punishable under section 114 R/w section 34 of IPC and within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.2 instigated accused No.1 to commit the offence and you accused No.1 committed the offence as abetted by you accused No.2 and that you have committed an offence punishable under section 109 R/w section 34 of IPC and within my cognizance.

Fourthly, that on the above said date, time and place you accused No.1, on the instigation of you accused No.2, with an intention to kill CW.1, voluntarily assaulted with your hands on the body of CW.1 and caused hurt to CW.1 and that you have committed an offence punishable under section 323 R/w section 34 of IPC and within my cognizance.

Fifthly, that on the above said date, time and place you accused No.1 on the instigation of you accused No.2, with an intention to kill CW.1, voluntarily assaulted with a chopper on the head of CW.1 and caused bleeding injury and that you have committed an offence punishable under section 324 R/w section 34 of IPC and within my cognizance.

Sixthly, that on the above said date, time and place you accused No.1 on the instigation of you accused No.2, with an intention to

commit murder of CW.1 Ravikumar assaulted him with a chopper on his head and caused bleeding injury, with such intention or knowledge and under such circumstances that by that act you had caused the death of Ravikumara, you would have been guilty of murder and that you have committed an offence punishable under section 307 R/w section 34 of IPC and within my cognizance.

Lastly, on the above said date, time and place you accused No.1 on the instigation of you accused No.2, told CW.1 to withdraw the old case registered against you accused No.2 otherwise you would kill CW.1 with chopper and thereby committed criminal intimidation by threatening CW.1 with injury to his person and that you have committed an offence punishable under section 506 R/w section 34 of IPC and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
