I, Bhanumathi B.C., B.A.L, LL.B., II Addl., District and Sessions Judge, Chikkamagaluru, do hereby charge you:-

as follows:

CHARGE

That on 21.11.2010, you accused No.1 married CW.1-Farjana Banu and after the marriage, CW.1 started residing

with you accused Nos.1 to 3 in your house situated at Masthambika temple street, K.M. Road, Kadur town within the jurisdiction of Kadur police station, since 3-4 years, with common intention, you accused No.1 to 3 being the husband and in-laws of CW.1 subjected her to physical and mental cruelty without any reason and thereby you accused committed the offence punishable under section 498-A of IPC r/w. section 34 of IPC and within my cognizance.

That on 24.04.2019 at about 8.30 p.m in the rented house belonging to CW.9 situated at Subhashnagar, Kadur town, within the jurisdiction of Kadur Police Station, you the accused Nos.1 to 3, with common intention to kill CW.1-Farjana Banu picked up quarrel with CW.1, you accused No.3 slapped on the face of CW.1, scratched in her chest with hand, you accused No.1 slapped on the face of CW.1 and caused simple hurt to her and thereby you the accused committed an offence punishable under section 323 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

That on the aforesaid date, time and place, you the accused in furtherance of your common intention picked up quarrel with CW.1, abused her in filthy language uttering "ಸೂಳೆ ಮುಂಡೆ ಬೋಳೆ ಮುಂಡೆ" gave provocation, knowing fully well that such provocation would cause her to break the public peace and thereby you the accused committed an offence punishable under section 504 of Indian Penal Code r/w. Section 34 of Indian Penal Code and within my cognizance.

That on the aforesaid date, time and place, you the accused in furtherance of your common intention and with knowledge that by your act, you would be causing death of CW.1 and under circumstances in which by your act CW.1 had died, you would have been guilty of murder, you accused No.2 instigated you accused No.1 to commit murder of CW.1 by pouring kerosene and you accused No.1 poured kerosene on the head of CW.1 and went to bring match box to

set fire on her and at that time, CW.1 went out by screaming and thereby you the accused committed an offence punishable under section 307 of IPC r/w. section 34 of IPC and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
