CHARGE

I, Prakash.V., B.A.(L), L.L.B., C/c II Addl. District and Sessions Judge, Chikkamagaluru, do hereby charge you:

A1 Praveen Kumar M.C
S/o Chandregowda M.P,
Aged about 30 years,
Driver,

A2 Chandregowda M.P
S/o Late Puttegowda M.P
Aged about 56 years,
Both are residing at Chanduvalli
village, Coove Post, Baluru Hobli,
Mudigere Taluk,Chikkamagaluru.

as follows:

That Subhiksha G.C was given in marriage to you accused No.1, that your marriage was performed on 29.05.2020 at Kalanatheshwara temple, Banakal village, after the marriage, deceased Subhikhsa was residing along with you accused No.1 and 2 in your house situated at Chanduvalli village, Baluru Hobli, Mudigere Taluk within the jurisdiction of Balur police station, Chikkamagaluru, about 2 years back with regard to assault made by you accused No.2

on the deceased Subhiksha, CW.1, 13, 17, 18, 19, 20 and 21 have convened panchayath and after that, you accused No.1 and deceased Subhiksha started to reside in another house and accused No.2 who is the father-in-law of the deceased and his wife Lakshmi started to reside in another house, thereafter, the deceased insisted to go to the job of teacher, for that, you accused No.1 and 2 started to harass her physically and mentally as the child is young, when the deceased asked you accused No.1 to let her go to the teacher's job, you accused abetted her to go and die and thereby you the accused with common intention having administered physical and mental cruelty to deceased Subhiksha, thereby you accused persons have committed an offence punishable under section 85 of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

2. Secondly, 2 years prior to the date of incident, during her stay in the matrimonial house, you accused No.2 assaulted Subhiksha with hands and thereby having voluntarily caused simple hurt to her, you accused committed an offence punishable under section 115(2) of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

3. Thirdly, you accused used to quarrel with Subhiksha for trivial matters and abuse her in filthy language, abetted her to go and die, that when Subhiksha expressed her to wish to go for work, you accused No.1 and 2 refused for the same and subjected her to cruelty and that Subhiksha could not bear the torture meted out to her by you, because of which on 19.08.2024 around 6.30 p.m, out of frustration,

when there were no one in the house, by putting bolt to the door from inside, she committed suicide by hanging and thereby you the accused No.1 having abetted the commission of suicide by Subhiksha you committed an offence punishable under section 108 of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
