Manjunathgowda, Aged 45 years,

A2. Jefry D' Souza S/o. Louis D'Souza, Aged  
60. about years,

A3. Jayaprakash D'Souza, S/o. Jefry D' Souza,  
Aged about 35 years,

A4. Lilly D'Souza W/o. Jefry D'Souza, Aged  
about 55 years,

All are Agriculturists, R/o. Echuvalli, Halekere  
village, Mudigere Taluk, Chikkamagaluru.

as follows:

That on 23.02.2013 at about 11.00 a.m., at Echuvalli in  
Halekere village, you accused Nos. 1 to 4, with common  
intention, in connection with a dispute pertaining to the burial  
ground in Sy. No. 47 of Halekere village, abused C.W.1/ Sri H.P.  
Raghu, in filthy language and thereby committed an offence  
punishable under Section 504 r/w. 34 of I.P.C., and within the  
cognizance of this court.

2. That, you the accused persons, on the aforesaid date,  
time and place, you, accused Nos.2 and 3, with common


intention, assaulted C.W.1 with clubs and stones and torn his shirt, and also assaulted C.W.2 with a stone on his left hand wrist, who intervened to pacify the quarrel, and caused bodily pain and thereby committed an offence punishable under Section 324 r/w. 34 of IPC and within the cognizance of this court.

3. That, you the accused persons, on the aforesaid date, time and place, with common intention, you accused No.1, assaulted on the left hand thumb finger, middle finger and right shoulder of C.W.1, with a chopper, with intention to commit murder of C.W.1, and caused grievous injuries to him and thereby committed an offence of attempt to murder punishable under Section 307 r/w. 34 of I.P.C. and within the cognizance of this court.

4. That, you the accused persons, on the aforesaid date, time and place, with common intention, you accused No.1, abetted accused Nos. 2, 3 and 4, to assault C.W.1 with chopper, and thereby committed an offence of abetment, punishable under section 114 r/w. 34 of I.P.C. and within the cognizance of this court.

And, I hereby direct that you be tried by this court on the above said charges.


