as follows:

That on 18.06.2018 at about 1.30 p.m., in Bhakthanakatte village, Tarikere Taluk, within the limits of Ajjampura Police Station, the complainant/CW1-Kumarappa had been to the land for sowing purpose, at that time, you accused were also preparing to sow the seeds, then the complainant asked you as to why you came to his land inspite of a case filed in Tarikere Court, you all the accused being the members of unlawful assembly with common object to commit murder of complainant and thereby committed the offence punishable under section 143 of IPC R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object, you all the accused, being the members of unlawful assembly committed rioting punishable under section 147 R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object, you all the accused being the members of unlawful assembly committed rioting armed with deadly weapons likely to cause death and thereby committed the offence punishable under section 148 of IPC R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object to commit murder of complainant, you all the accused abused the complainant in filthy language intentionally insulted him, knowing it to be likely that such provocation will cause them to break

the public peace and thereby committed the offence punishable under section 504 R/w section 149 of IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object, you accused No.2 voluntarily assaulted CW.1/complainant with your hand on his cheek and kicked on his stomach and made fallen on ground and voluntarily caused hurt to him and thereby committed the offence punishable under section 323 of IPC R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object, you accused No.3 voluntarily assaulted CW.1/complainant with log on behind his head and you accused No.1 voluntarily assaulted CW.1 with sickle on his right hand thumb and voluntarily caused greivous injuries to him and thereby committed the offence punishable under section 324 of IPC R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object to commit murder of CW.1, you accused No.4 & 5 hold the CW.1 tightly with the help of your hands, thereafter you accused No.1 assaulted CW.1 with sickle on his neck, but the complainant tried to escape the said blow, it fell on his left thumb and caused grievous injuries, with such intention or knowledge and under such circumstances that by that act you had caused the death of CW.1-Kumarappa, you would have been guilty of murder and that you have

committed an offence punishable under section 307 of IPC R/w section 149 of IPC and within the cognizance of this Court.

That on the above said date, time and place, in furtherance of common object to commit murder of CW.1, caused life threat and committed criminal intimidation by threatening CW.1 with injury to his person and that you have committed an offence punishable under section 506 R/w section 149 of IPC and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the above said charges.
