C H A R G E

I, Manjunath Sangreshi., B.A., LL.B.,(HONS), II Addl.,
District and Sessions Judge, Chikkamagaluru, do hereby charge
you,

1. Anu Jobi S/o Jobi,
Aged about 30 years, Businessman,
R/o Muthinakoppa village, N.R.Pura Taluk,

2. Jobi Jose W/o Jose,
Aged about 34 years, Businessman,
R/o Muthinakoppa village, N.R.Pura Taluk,

as follows:

That on 18.06.2019 at about 6.00 p.m., in Muthinakoppa
village, within the limits of N.R.Pura police Station, when
CW.1 vacating the compound wall constructed by the side of
hotel, which is run by you accused on rent basis obtained from
CW.1, with common intention, you both the accused abused
them in filthy language and gave provocation to them intending
or knowing it to be likely that such provocation will cause to
break public peace and thereby committed the offence
punishable under section 504 R/w section 34 of IPC and within
the cognizance of this Court.

Thirdly, that on the above said date, time and place you both the accused, in furtherance of common intention to commit murder, you accused No.1 assaulted CW.2 with knife on her neck, caused bleeding injuries, with such intention or knowledge and under such circumstances that by that act you had caused the death of Kum:Mariya, you would have been guilty of murder and that you have committed an offence punishable under section 307 of IPC R/w section 34 of IPC and within the cognizance of this Court.

Lastly, on the above said date, time and place, in furtherance of common intention to commit murder of CW.2, you accused No.1 assaulted CW.2, caused injuries and thereby committed criminal intimidation by threatening CW.1 and CW.2 with injury to them and that you have committed the offence punishable under section 506 R/w section 34 of IPC and within my cognizance.

And I hereby direct that you be tried by this Court on the above said charges.
