Complainant: State by Tarikere Police

Versus

Accused: Sandeep and another

CHARGE

I, K.L.Ashok, B.Com., L.L.B, 1st Addl. Sessions and Special Judge, Chikkamagaluru, do hereby charge you:

1. Sandeep, S/o Late Lokesh, Aged about 23 years,
2. Smt.Kavitha, W/o Late Lokesh, Aged about 42 years,

Both are agriculturists, R/o M.C.Halli,
Tarikere Taluk.

as follows:

That on 04.10.2019 at about 2.00 p.m. at H.Rangapura Village, Tarikere Taluk, coming within the jurisdiction of Tarikere Police, when the survey and revenue officers were measuring the land bearing Sy.No.77, you accused No.1 and 2 did not allow them to survey the land saying that there is a civil suit pending

before the Court and when they stopped surveying and returned, at that time, you accused No.1 and 2 with common intention abused CW1 Smt.Mahalakshamma, CW8 Smt.Shwetha and CW9 Rangaswamy in filthy language and insulted them and provoked them to commit breach of peace and thereby committed the offence punishable under section 504 r/w Section 34 of I.P.C., and within the cognizance of this Court.

Secondly, on the aforesaid date, time and place, in furtherance of your common intention, you accused voluntarily caused hurt to CW1 Smt.Mahalakshamma by assaulting her with hands on her person and thereby committed an offence punishable under Section 323 r/w Section 34 of I.P.C. and within the cognizance of this Court.

Thirdly, on the above said date, time and place, in furtherance of your common intention, you accused used criminal force on CW1 Smt.Mahalakshamma with intent to outrage her modesty and thereby committed an offence punishable under

Section 354 r/w Section 34 of I.P.C. and within the cognizance of this Court.

Fourthly, on the aforesaid date, time and place, in furtherance of your common intention, you accused persons criminally intimidated CW1, CW8 and CW9 by giving life threat and thereby committed an offence punishable under Section 506 r/w Section 34 of I.P.C. and within the cognizance of this Court.

Fifthly, on the aforesaid date, time and place, you accused persons not being the member of Scheduled Caste or Scheduled Tribe, intentionally insulted CW1, CW8 and CW9, members of Scheduled Caste/Tribe, with intent to humiliate them within public view, by abusing them by touching the name of their caste, and thereby committed the offence punishable under Section 3(1)(r) and 3(1)(s) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

Lastly, on the aforesaid date, time and place, you accused persons not being the member of Scheduled Castes or Scheduled Tribes, committed offence under Sections 323, 354 and 506 of

I.P.C against CW1, CW8 and CW9 knowing that they are the members of Scheduled Caste / Tribe and thereby committed an offence punishable under Sec. 3(2)(va) of the SC & ST (Prevention of Atrocities) Act, and within the cognizance of this Court.

And I hereby direct that you be tried by this Court on the said charges.
