:: COMMITTAL ORDER ::

The Circle Inspector of Kadur Circle filed the charge-sheet against the Accused persons, alleging the commission of offences punishable under Sections **103(1), 238, R/w.Sec.3(5) of BNS.** **The accused No.5 has been shown in the charge sheet as absconding.**

2. Accused No.1 produced on 12.10.2025 at first since he is in J.C. The accused No.2 and 3 have enlarged on bail as per the order passed by the Hon'ble I Addl. District and Sessions



Judge, Chikkmagaluru in Crl.Mis.No.548/2025 dated 07.11.2025. Accused No. has been enlarged on bail as per the orders passed by the Hon'ble I Addl.District and Sessions Judge, Chikkmagaluru in Crl.Mis.No.659/2025 dated 29.12.2025. The case against Accused No.5 has been ordered to be split up.

3. The copy of the charge-sheet and its enclosures furnished to the accused No.1 to 4 before this court as required under Section 230 of B.N.S.S..

4. Case properties item No.1 to 5 subjected at P.F.No.203/2025, the properties subjected in P.F.No.204/2025 i.e. another shirt and pant, the properties subjected in P.F.No.205/2025 i.e., one stone, the property subjected in P.F.No.215/2025 i.e. one shirt and pant, the property subjected in P.F.No.218/2025 i.e., item No.1 to 7 are received and item No.8 to 10 were sent to FSL and all properties subjected to P.R.No.31/2026. The property subjected in P.F.No.216/2025 i.e., Mahendra 7 Bolloro Max car bearing Reg.No.KA 18 C 7804 has



been released to the interim custody of applicant by name Nanjunda.

5. Accused No.2, 3 and 4 are released on bail and accused No.1 in JC and the offences alleged against the accused persons are punishable under Sections **103(1), 238, R/w.Sec.3(5) of BNS**, which are exclusively triable by Hon'ble Court of Sessions. Hence, acting under Section 232 of BNSS I proceed to pass the following:

ORDER

Acting under Section 232 of BNSS the case is committed to the Hon'ble District and Sessions Court, Chickmagaluru for trial.

The Superintendent of District Prison, Chickmagaluru is directed to produce the Accused No.1 before the Hon'ble Court of Sessions, whenever called upon by the Hon'ble Court of Sessions.

Accused No.2 to 4 are directed appear before the Hon'ble Sessions court, whenever called upon.



Office is directed to send the entire records to the Hon'ble Prl. District and Sessions Court, Chickmagaluru by making proper index.

Office is hereby directed to send the intimation to the J.C. about the committal of this case to the Hon'ble Prl. District and Sessions Court and also directed to submit the properties in the present case before Hon'ble Prl.District and Sessions Court.

Notify the order of committal to the Public Prosecutor, Chickmagaluru.
