(b) For court costs and such other reliefs as this Hon'ble Court deems fit to grant under the circumstances of the case.

This suit is coming on 31st day of March 2022 for final disposal before Sri. Deepu M.T. B.A.L. LLB., III Addl.Civil Judge & J.M.F.C., Kadur in the presence of Sri. C.V.S, advocate for plaintiff and Sri. D.N.P/ K.A.S, advocates for defendant No.1 to 4. On 08.02.2021 retired on behalf of defendants No.1 and 2, hence defendants No.1 and 2 remained absent.

After contest by pronouncing judgment, it is ordered and decreed that the suit of the plaintiffs is hereby decreed with costs.

It is further ordered and decreed that the defendants are hereby permanently restrained from obstructing, interfering and encroaching with the lawful possession and enjoyment of the plaintiffs over the plaint schedule properties in any manner.
